THE SINDH REGULARIZATION OF VETERINARY DOCTORS APPOINTED ON CONTRACT BASIS ACT, 2018

to provide for the regularization of the services of certain doctors appointed on contract basis under district-wise Veterinary Service Program of Livestock and Fisheries Department, Government of Sindh.

WHEREAS It is expedient in the public interest to provide for the regularization of the services of certain doctors appointed on contract basis under district-wise Veterinary Service Program of Livestock and Fisheries Department, Government of Sindh, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Regularization of Veterinary Doctors appointed on Contract Basis Act, 2018. **Short title and commencement.**

(2) It shall come into force at once.

2. In this Act, unless context otherwise requires -

Definitions.

- (a) "Act" means the Sindh Civil Servants Act, 1973;
- (b) "appointment of a Veterinary Doctor on contract" means the appointment of a duly qualified Veterinary doctor made on contract basis in the Program;
- (c) "civil servant" shall have the same meaning as assigned to it in the Act;
- (d) "Government" means the Government of Sindh;
- (e) "post" means a post sanctioned by Government connected with the affairs of the Province but does not include the post earmarked for a Project and co-exist with such Project; and
- (f) "Program" means the district-wise Veterinary Service Program of Livestock and Fisheries Department, Government of Sindh.

3. Notwithstanding anything contained in the Act or rules made thereunder or any decree, order or judgment of a court, but subject to other provisions of this Act, a Veterinary doctor appointed on contract basis in the Program, and holding such post immediately before the commencement of this Act, shall be deemed to have been validly appointed to that post as a civil servant on regular basis, with effect from the date of commencement of this Act:

Regularization of services of Veterinary doctors.

Provided that the services of Veterinary Doctor, who does not possess the qualifications, prescribed for the post, shall not be regularized.

Provided further that no Veterinary Doctor shall be transferred from the District unless the replacement of such doctor is available.
