PREIMINARY

- (1) These rules may be called the Sindh Govt. Land Short title and (Cancellation of Allotments Conversions commencement. Exchanges), Rules, 2003.
 - (2) They shall come into force at once.
- 2. In these rules, unless there is anything repugnant **Definitions.** in the subject or context-
 - (a) "Chairman" means the Chairman of the Committee;
 - (b) "District Officer" means the District Officer (Revenue) of the District as described in the Sindh Land Revenue Act, 1967;
 - (c) "Member" means Member of the Committee;
 - (d) "Ordinance" means the Sindh Government Land (cancellation of Allotments Conversions, Exchanges)Ordinance, 2001; and
 - (e) "Section" means a Section of the Ordinance.
- 3. (1) For the purpose of determining the market **Market Price** price, the Committee shall take into consideration:-
 - (i) the transfer of land similarly situated and in similar use during the past twelve months.
 - the valuation table notified under the Stamp Act, 1899 for the purpose of levy of stamp duty at the time of registration of a sale deed; and
