SINDH ACT NO.I OF 2009 THE SINDH PUBLIC PROPERTY (REMOVAL OF ENCROACHMENT) (AMENDMENT) **ACT, 2008**

[29th January, 2009]

An Act to further amend the Sind Public Property (Removal of Encroachment) Act, 1975.

WHEREAS it is expedient to further amend the Sind Public Preamble Property (Removal of Encroachment) Act, 1975, in the manner hereinafter appearing;

It is hereby enacted as follows: -

- This Act may be called the Sindh Public Property Short title and (Removal of Encroachment) (Amendment) Act, 2008. commencement.
 - (2)It shall come into force at once.
- 2. In the Sind Public Property (Removal of Encroachment) Amendment of Act, 1975, hereinafter called the said Act, in section 2, for clause section 2 of Sind (f). the following shall be substituted:-

Act No.V of 1975.

- "(f) "Council" means a Council as defined in the Sindh Local Government Ordinance, 2001.".
- Through out the Act, for the words "Local Council", the **Amendment of** word "Council" shall be substituted.

section 3 of Sind Act No.V of 1975.

4. In the said Act, in section 3, in sub-section (1), for the **Amendment of** words "three days", the words "two days" shall be substituted.

section 3 of Sind Act No.V of 1975.

In the said Act, in section 4, in sub-section (1), for the words "seven days", the words "three days" shall be substituted.

<u>Amendment</u> of section 4 of Sind Act No.V of 1975.

6. In the said Act, in section 5, in sub-section (1), for the words "seven days", the words "three days" shall be substituted.

Amendment of section 5 of Sind Act No.V of 1975.

7. In the said Act, in section 8, for sub-section (1), the Amendment of following shall be substituted:-

section 8 of Sindh Act No.V of 1975.

"(1) Any person responsible for encroachment, may be punished with imprisonment of either description for a term which may extend to five years but not less than one year and with fine which may extend to five lac rupees. ".

8. In the said Act, after section 15, the following new section **Insertion of** shall be inserted:section 15-A.

"15-A. Government may for the prevention of Establishment of public property and to enforce the Antiencroachment on provisions of the Act, establish an Anti-Encroachment **Encroachment** Force in the prescribed manner.".

9. In the said Act, after section 17, the following shall be Addition of added:-

section 18 in the Sind Act No.V of 1975.

"18. The provisions of this Act shall have over-riding Act to over-ride effect notwithstanding anything contained in any other laws. other law for time being in force.".
