## ACT NO.XIX of 18381.

## [THE <sup>2\*</sup>[COASTING-VESSELS ACT, 1838]

[27<sup>TH</sup> August, 1838]

- 1. [Repeal of enactments.] Rep. by the Repealing Act, 1870 (XIV of 18700.
- 2.  $3^*$  \* The Following rules shall be in force with respect to vessels belonging to any 4[citizen of Pakistan] residing within 5[Sind], and employed on the coasts of 6[Sind], or in trading coastwise, as also with respect to fishing-vessels and harbour-craft belonging to any 7[Such citizen.].

Rules as to coasting and other vessels belonging to citizen of Pakistan.

3. 8\* \* Every such vessel employed as foresaid, fishing-vessels and harbour-craft shall be marked or branded with the name of the place to which she belongs, and also with a number assigned for the same by the officer authorized to make such registry as is hereinafter mentioned;

Marking or branding vessels with name of place and number.

and the owner or owners of such vessel employed as aforesaid, fishing-vessel and harbour-craft shall cause such name and number to be painted in black paint upon a white ground on each quarter of such vessel employed as aforesaid, fishing-vessel and harbour-craft, ion English figures and letters, each figures and letter being six inches in length.

4. 8\* \* The name and number of every such vessel employed as aforesaid, fishing-vessel and harbour-craft, and her burthen, and also the name or names of the owner or owners, thereof, shall be registered in a book to be kept for that purpose by the person hereinafter directed to make such registry.

execution of this Act; and whenever any change shall take place in the burthen of such vessel employed as aforesaid, fishing-vessel or harbour-craft, or in the name or names of the owner or owners thereof, such registry shall be made again:

Fresh registration.

Provided, however, that it shall not be lawful to give any name to such vessel employed as aforesaid, fishing-vessel or harbour-craft, other than that by which she was first registered.

5. 1\* \* The owner or owner of every such vessel employed as aforesaid, fishing-vessel and harbour-craft shall apply to the person authorized to make such registry in respect of the same, in order to have such registry as aforesaid made, or in order to have such registry made again as aforesaid.

Owners to apply for registry.

And whenever such vessel employed as aforesaid, fishing-vessel or harbour-craft is registered at <sup>2</sup>[a place other than Karachi], information thereof, and of the number there assigned to her, shall immediately be given by the registering officer to <sup>3</sup>[the Principal Officer].

Information of registry at subordinate port.

6. 1\* \* \*The duty of marking or branding and of ascertaining the burthen of such vessels employed as aforesaid, fishing-vessels an harbour-craft, 4[at Karachi, shall be performed by <sup>5</sup>[The Principal Officer]; and at all other places <sup>6</sup>[within <sup>9</sup>[Sind]], the duty of marking or branding and of ascertaining the burthen of such vessels employed as aforesaid, fishing-vessels and harbour-craft shall be performed by the Collector of Sea-Customs at such places respectively, or by such other persons as shall be appointed by the <sup>7</sup>[Federal Government] to act at such places respectively, in the execution of this Act.

Officers to perform duty of marking and branding.

7. 1\* \* The owner or owners of every such vessel employed as aforesaid fishing-vessels and harbour-craft shall apply for and obtain a certificate of registry from the person authorised to make such registry as aforesaid, and such certificate shall be in the form specified in the Schedule appended to this Act; and in the case of any certificate being lost or destroyed, a renewed certificate may be obtained in the same manner and on payment of the fees hereinafter mentioned.

8. 1\* \* \* Such certificate of registry shall be sealed with the seal of the 8[Federal Government] and shall be signed by the person authorised to make such registry.

- [Dates for commencement of certificate and registration.] Rep. by the Repealing Act, 1876 (XII of 1876).
- \* \* The owner or owners of such vessels employed as 10. Fees for certificates. aforesaid (fishing-vessels and harbour-craft being excepted) on being registered as aforesaid, shall pay—

for each certificate registry for a vessel not exceeding <sup>2</sup>[5 tons] burthen, the fee of .. .. .. 1 rupee. for each certificate for a vessel exceeding <sup>2</sup>[5 tons] burthen, and not exceeding 3[25 tons] burthen 5 rupee. for each certificate for a vessel exceeding <sup>2</sup>[25 tons] burthen and not exceeding 5[100 tons] burthen 7 rupees. and for each certificate for a vessel of 100 tons or greater burthen, 13 paisas.

11. The person or persons so authorized to make such Fees to be registry as aforesaid shall receive the fees payable for the same, and shall pay such fees to such officer as the 6[Federal Government] shall appoint; the same to be carried to the credit of the <sup>7</sup>[Federal Government]:

8[Provided that any such fees as immediately before the commencement of Part III of the Government of India Act, 1935, were, under this Act as then in force to be carried to the credit of the Local Government shall be paid to such officer as the Provincial Government may appoint and be carried to the credit of that Government.]

12. The owner or owners or commander of every shall vessel employed as aforesaid, fishing-vessel and harbour-craft shall produce, on demand thereof by any officer of the Custom within 10[the Sind), or by any officer of the 9\*Navy, the certificate so directed to be applied for and obtained, in respect of such vessel employed as aforesaid, fishing-vessel or harbour-craft, as above mentioned.

Production of certificate on demand.

\* In case any such vessel employed as aforesaid, fishing-vessel or harbour-craft shall not be so marked or branded in all respects as hereinbefore directed, or in case the name and number of any such vessel employed as aforesaid, fishing-vessel or harbour-craft shall not be so painted, or shall not continue so painted on such vessel employed as aforesaid, fishing-vessel or harbour-craft, in all respects as hereinbefore directed:

hereinbefore specified, or in case the owner or owners or commander of any such vessel employed as aforesaid, fishing-vessel or harbourcraft shall not produce such certificate on demand thereof as hereinbefore directed:

The owner or owners of every such vessel employed as aforesaid shall be subject to a fine of ten times the amount of the fees payable in respect of the certificate of registry of such vessel, the same being a vessel for the certificate of the registration of which any fee is payable; and the owner or owners of any such fishing-vessel or harbour-craft shall be subject to a fine of ten rupees;

Which fines make be recovered on conviction before any Recovery of \* having jurisdiction within 2[the Sind] by sale Penalties. Maaistrate \* of such vessel, fishing-vessel or harbour-craft, her furniture, ammunition, tackle and apparel;

And such fines shall be payable as often as the owner or owners Penalty on or commander of any such vessel employed as aforesaid, fishingvessel or harbour-craft shall make such default as aforesaid: Provided of default. every such subsequent default be made after the expiration of one month from the date of the last conviction.

\* The 4[Federal Government] may direct Power to compensation for trouble and diligence in seizing such vessel direct comemployed as aforesaid, fishing-vessel or harbour-craft, guns, furniture, tackle, ammunition and apparel, as last mentioned, to be made, out for trouble of the proceeds of such seizure to the person or persons who shall in seizing. have seized the same, to such amount, in such manner and in such shares or proportions, as to the said <sup>5</sup>[Federal Government] shall seem meet.

All references in this Act to the <sup>2</sup>[Federal Government], the Principal Officer and the Collector of Sea-customs shall, in relation to coastal shipping confined to ports within the Province of <sup>2</sup>West Pakistan, be construed respectively as references to the Government of <sup>3</sup>West Pakistan and to such officer or officers as that Government may, by notification in the Official Gazette, appoint in this behalf.]
