SINDH ACT NO. IX OF 2018

ACT**

to amend the Barrett Hodgson International University at Karachi Act, 2015 (Sindh Act No. XL)

WHEREAS it is expedient to amend the Barrett Hodgson International University Act, 2015 in the manner hereinafter appearing. **Preamble.**

It is hereby enacted as follows:

1. (1) This Act may be called the Barrett Hodgson International University at Karachi (Amendment), Act 2016. **Short title and commencement.**
- (2) It shall come into force at once.

2. In the said Act the word appearing "International" in the title and the Preamble and wherever it appears is omitted. **Definitions.**
3. In the said Act wherever the word "Chairman" appears is substituted by the word "Chairperson".
4. Section 17(1) to be substituted as under: **Board of Governors.**
Section 17(1). The Board shall consist of a Chairperson and Members as under:
- (a) Dr. M.S Habib-whose name appears in the Preamble, shall be the life time Chairperson, **however in case of his demise or he is incapacitated to perform his duties, the Board shall elect its nominee.**
- (b) The Chancellor
- (c) The Vice Chancellor
- (d) A serving or retired Judge of the High Court to be appointed/nominated by the Chief Justice, High Court of Sindh.
- (e) A nominee of the Higher Education Commission.
- (f) Secretary to the Government of Sindh, Education Department or his nominees.
- (g) **Two persons of outstanding merit to be nominated by the Foundation and two members of the Provincial Assembly to be nominated by the Speaker.**
- (h) Five persons of eminence representing various disciplines and professions, nominated by the Chancellor in consultation with the Vice Chancellor.
