THE SIND ADAPTATION OF LAWS ORDER, 1975.

[22nd July, 1975]

WHEREAS clause (3) of Article 268 of the Constitution of the Islamic Republic of Pakistan provides that, for the purpose of bringing the provisions of any existing law into accord with the provisions of the Constitution, the President may, by Order, make such adaptations, whether by way of modification, addition or omission, as he may deem to be necessary or expedient;

Preamble.

AND WHEREAS under the Government of Pakistan, Ministry of Law and Parliamentary Affairs (Law Division) Notification No.S.R.O./1328(I)/73, dated the 17th September, 1973, the President has been pleased to authorize the Governors of Provinces, to exercise, in relation to their respective Provinces, the powers conferred on him by clause (3) of the said Article, in respect of laws relating to matters with respect to which a Provincial Assembly has power to make laws;

NOW, THEREFORE, in exercise of the powers conferred as aforesaid, the Governor of Sind is pleased to make the following Order: —

1. (1) This Order may be called the Sind Adaptation of Laws Order, 1975.

Short title and commencement.

(2) It shall come into force at once.

2. (1) The laws specified in the Schedule to this Order shall, until repealed or amended by the competent authority, have effect subject to the adaptations directed by the Schedule.

Adaptation of laws.

(2) References to any law in the Schedule shall, unless expressly amended or modified by any other law, be construed as references to that law as amended or modified by this Order.
