Karachi, the 6th July, 2005

NO.PAS/LEGIS-B-1/2005-. The Sindh Boards of Intermediate and Secondary Education (Amendment) Bill, 2005 have been passed by the Provincial Assembly of Sindh on 13th May, 2005 and assented to by the Governor of Sindh on 28th June, 2005, is hereby published as an Act of the Legislature of Sindh.

THE SINDH BOARDS OF INTERMEDIATE AND SECONDARY EDUCATION (AMENDMENT) ACT, 2005.

SINDH ACT NO.II OF 2005

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 6th July, 2005).

AN ACT

to amend the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972.

Preamble

WHEREAS it is expedient to amend the Sindh Boards of Intermediate and Secondary Education: Ordinance, 1972, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and

- (1) This Act may be called the Sindh Boards of Intermediate and Secondary Education (Amendment) Act, 2005.
 - (2) It shall come into force at once.

Amendment of section 2 of Sind Ordinance VI of 1972. 2. In the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972, hereinafter referred to as the said Ordinance, in section 2, in clause (u), for the words "Board at Hyderahad", the words "Boards at Hyderahad and Mirpurkhas" shall be substituted.

Amendment of section 3 of Sind Ordinance VI of 1972.

- 3. In the said Ordinance, in section 3, in sub-section (1):-
 - (i) in clause (c), the word "and" occurring at the end shall be deleted;
 - (ii) in clause (d), for the full stop occurring at the end, the semi colon and the word "arc" shall be substituted and thereafter the following shall be added:-
 - "(e) at Mirpurkhas, a Board called the Board of Intermediate and Secondary Education, Mirpurkhas."

Amendment of Section 4 of Sind Ordinance VI of 1972.

- 4. In the said Ordinance, in section 4, in sub-section (1), in clause (iii)-
 - (i) in sub-clause (d), the word "and" occurring at the end shall be deleted;

- (ii) in sub-clause (e), for the full stop occurring at the end, a semi colon and the words "and" shall be substituted and thereafter the following shall be added:-
 - "(f) the Board of Intermediate and Secondary Education Mirpurkhas, the Executive District Officer Education."
- 5. In the said Ordinance, in the Schedule, for the word "Hyderabad" wherever occurring the words "Hyderabad or Mirpurkhas" shall be substituted.

Amendment of Schedule to Sind Ordinance VI of 1972.

6. The Sindh Boards of Intermediate and Secondary Education (Amendment) Ordinance, 2004 is hereby repealed.
