NO.PAS/LEGIS-B-10/2003-. The Institute of Business and Technology Bill, 2003 have been passed by the Provincial Assembly of Sindh on 8th December, 2003 and assented to by the Governor of Sindh on 5th January, 2004, is hereby published as an Act of the Legislature of Sindh.

THE INSTITUTE OF BUSINESS AND TECHNOLOGY ACT, 2003.

SINDH ACT NO.II OF 2004

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 12th January, 2004).

to provide for the establishment of an Institute at Karachi known as the Institute of Business and Technology.

Whereas it is expedient to provide for the establishment of an Institute at Karachi known as the Institute of Business and Technology and to provide for matters ancillary thereto;

Preamble.

It is hereby enacted as follows: -

Short title and commencement.

- This Act may be called the Institute of Business and Technology Act, 2003.
 - (2) It shall come into force at once.

Definitions.

- 2. in this Act, unless there is anything repugnant in the subject or context -
 - (1) "Academic Council" means the Academic Council of the Institute;
 - (2) "Authority" means any Authority of the Institute;
 - (3) "Board" means the Board of Governors of the Institute;
 - (4) "Chairman" means the Chairman of the Board;
 - (5) "Commission" means the Higher Education Commission;
 - (6) "Dean" means the Dean of a Faculty;
 - (7) "Faculty" means the Faculty of the Institute;
 - (8) "Government" means the Government of Sindh;
 - (9) "Head" means head of a Teaching Department;
 - (10) "Institute" means the Institute of Business and Technology;
 - (11) "Patron" means the Governor of Sindh;
 - (12) "prescribed" means prescribed by statutes, regulations and rules;
 - (13) "Rector" means the Rector of the Institute;
 - (14) "Registrar" means the Registrar of the Institute;
 - (15) "Society" means the Global Educational Consultants Society registered und the Society Registration Act, 1860, vide registration No. KAR No. 195 of 201 dated 05-10-2001.
 - (16) "statutes, regulations and rules" means the statutes, regulations and rule respectively made under this Act; and
 - (17) "teacher" means Professor, Associate Professor, Assistant Professor as Lecturer engaged whole time by the Institute and includes such person declared as such under this Act;

- (18) "Teaching Department" means the Teaching Department established and maintained by the Institute;
- There shall be established at Karachi, an Institute to be known as the Institute of Business and Technology consisting of -
 - (a) the Chairman, the Rector, the Deans and other members of the Board;
 - (b) the teachers and students of the Institute and its constituent units;
 - (c) the members of such councils, committees and other bodies as the Boa'd may establish; and
 - (d) such other officers and members of the staff as may from time to time be specified by the Board.
 - (2) The Institute shall be a body corporate by the name of the Institute of Business and Technology, having perpetual succession and a common seal, with power, amongst others, to acquire, hold and dispose of any property or investments and shall by the said name sue and be sued.
 - (1) The powers and functions of the Institute are subject to the instructions prescribed by the Government of Sindh from time to time. The institute shall have the powers: -
 - (a) to provide for instructions and training in such branches of learning as it may deem fit, and to make provision for research, demonstrations and other services for the advancement and dissemination of knowledge;
 - (b) to admit and examine students:
 - (c) to hold examinations and confer or award degrees, diplomas, certificates and other academic distinctions on and to the persons who have passed its examinations under the prescribed conditions;
 - (d) to select and promote faculties:
 - (e) to confer honorary degrees;
 - (f) to prescribe courses of studies in various branches of learning established by the Iristitute;
 - (g) to pursue research;
 - (h) to establish and support other facilities for education, training and research;
 - (i) to enter into agreements, contracts and arrangements with Universities, Organizations, Institutions, bodies and individuals for the purpose of carrying out its functions and activities;

Establishment and incorporation of the lostitute.

Powers and functions of the Institute.

- to decide teaching methods and strategies in order to ensure the most effective educational and training programmes; and
- (x) in the exercise of above powers and functions, the institute shall be subject to any general rules, instructions or directions given by the Government of Sindh from time to time.
- (2) The powers and functions under sub section (1) shall be exercised and performed subject to general control and directions of Government from time to time.

Institute open to all. 5.

The Institute shall be open to persons of either sex of whatever religion, race, creed, colour or domicile who are academically qualified for admission to the courses of study offered by the Institute and no such person shall be denied the privileges of the Institute on the ground of sex, religion, creed, race, class, colour or domicile.

Teaching and examinations in the Institute.

6.

- 7.

- (1) The academic programmes of the Institute shall be conducted in the prescribed manner.
- (2) The institute shall associate external examiners for the conduct of maminations.
- (3) No degree shall be granted unless a student has passed an examination in Islamic Studies and Pakistan Studies at the Bachelor's degree level or, in the case of a non-Muslim student, in Ethics or Pakistan Studies at his option.
- (4) In prescribing syllabi, courses of studies and instructions for the conduct of studies, the Institute shall abide by the directions given from time to time by Government or the Commission.

Authorities of the Institute. .The following shall be the Authorities of the Institute: -

- (1) The Board;
- (2) the Academic Council;
- (3) the Advanced Studies and Research Board;
- (4) the Finance and Planning Committee;
- (5) the Selection Board; and
- (6) any other Authority constituted by the Board.

The following shall be the officers of the Institute: -

Officers of the Institute.

- (1) The Chairman;
- (2) the Rector.
- (3) the Deans,
- (4) the Heads of the Teaching Department;
- (5) 'the Registrar; and
- (6) such other persons as may be specified by regulations to be the officers.
- The Governor of Sindh shall be the Patron of the Institute.

Patron.

- (2) The Patron shall, when present, shall preside at the convocation of the Institute.
- (3) The appointment of the Chairman BOG of the Institute shall be made by the Patron for a tenure of 4 years from a panel recommended by the Trust/ Society/ Foundation or Company.
- (4) The appointment of the Rector / Director shall be made on the prescribed terms and conditions.
- (5) Every proposal to confer an honorary degree shall be subject to confirmation by the Patron.
- 10. (1) The Patron may cause an inspection or inquiry to be made on his own motion in respect of any matter connected with the affairs of the institute and shall, from time to time, direct any person or persons to inquire into or carry out inspection of -

Visitation.

- (a) the institute, its buildings, laboratories, libraries and other facilities;
- (b) any institution, department or hostel maintained by the Institute;
- (c) the adequacy of financial and human resources of the Institute;
- (d) the teaching, research, curriculum, examination and other matters of the Institute; and
- (e) such other matters as may be specified by him.
- (2) The Patron shall communicate to the Board his views with regard to the results of the visitation and shall, after ascertaining the views of the Board advise the Board on the action to be taken by it.
- (3) The Board shall, within such time as may be specified by the Patron, communicate to him such action, if any, as has been taken or may be proposed to be taken upon the results of the visitation.

- Where the Board does not, within the time specified, take action or the action taken is not to the satisfaction of the Patron, the Patron may issue such directions as he deems fit and the Board shall comply with all such directions.
- (5) The Patron shall have full powers to take any action, as he may deem fit against the Institute, including withdrawal of Charter and its closure.

Chairman.

- 11. (1) The Chairman shall be appointed by the Patron from a panel recommended by the Society on such terms and conditions as the Patron may determine.
 - (2) The Chairman shall in the absence of the Patron preside over the convocation.
 - (3) If the Chairman is satisfied that the proceedings of any Authority or orders of any officer are not in accordance with the provisions of this Act, the statutes, the regulations or the rules, he may, after calling upon such Authority or officer to show cause why such proceedings should not be annulled, by order in writing, annul such proceedings or orders.
 - (4) The Chairman may remove any person from the membership of any Authority if such person -
 - (a) has become of un sound mind; or
 - (b) has been incapacitated to function as member of such Authority; or
 - (c) has been convicted by court of law for an offence involving moral turpitude or has been found indulging in any activity against the interest of the Institute.
 - (5) Should the Chairman be incapacitated from acting as such due to absence or any other cause, the Rector or nominee of the Chairman shall act for him
 - (6) The Chairman Board of Governors in case of an institute shall appoint the Director on the recommendation of the Board of Governors.

Terms and conditions of appointment of Rector.

- (1) The Rector who shall be an eminent scholar of national or international repute and an educationist of distinction shall be appointed by the Chairman with the approval of the Board for a period of four years and on such terms and conditions as the Board may determine.
- (2) The Rector shall be the Chief academic and administrative officer of the Institute and shall be responsible for the implementation of the decision of the Board and for the execution of the programmes of the institute in accordance with the guidelines and policies formulated by the Board.

- (a) to submit plans of work and budget estimates of the Institute to the Board for consideration and approval;
- (b) to direct the activities connected with the execution of programmes for instructions, training, research, services to community;
- (c) to incur expenditure provided for in the approved budget and to reappropriate funds within the same major head of expenditure and report it to the Board in the next meeting;
- (d) to sanction and re-appropriate an amount not exceeding one lac rupees for an unforeseen item not provided for in the budget and report it to the Board in the next meeting;
- (e) to appoint, on the recommendations of the Selection Board and with the approval of the Board, teachers, officers, and members of the staff of the Institute and such other persons as may be necessary in accordance with policies and procedures approved by the Board so as to ensure the highest intellectual and moral qualities in the persons appointed;
- to submit to the Board, in accordance with the rules of procedure, reports on the activities of the Institute and the execution of the plans of work;
- (g) to create temporary posts for a period not exceeding six months;
- '(h) to undertake any work assigned by the Board.
- 13. (1) The Board shall consist of the Chairman and Members as follows-
 - (a) The Chairman;

Board.

- (b) a judge of the High Court of Sindh nominated by the Chief Justice;
- (c) Chairman, of the Commission or his nomines;
- (d) Secretary Education or his nominee not below the rank of an Additional Secretary;
- (e) three nominees of the Society.
- (i) Chairman, Chamber of Commerce and Industry;
- (ij) one scientist of national or international repute nominated by the Board; and
- (n) the Rector, who shall also be the Secretary of the Board.
- (2) The members of the Board other than the ex-officio members shall hold office for a period of three years.

- (3) No act or proceedings of the Board shall be invalid by reason only of the existence of a vacancy in, or any defect in the constitution of the Board.
- (4) The Chairman may nominate any Member of the Board of Governors to act as Chairman in his absence.

Powers and functions of the Board.

- 14. The Board shall exercise and perform the following functions: -
 - (1) to hold, control and administer the property, funds and resources of the Institute and raise funds for the purpose of the Institute upon such security as may be required under regulations;
 - to undertake responsibility for the financial viability of the institute including imponsibility for ensuring effectiveness of its operations, their continuity and preservation of the autonomy of the Institute;
 - (3) to consider and pass annual report, plan of work, statement of accounts and the annual budget estimates;
 - (4) to formulate or approve the principles, policies and plans governing the activities and operations of the Institute so as to facilitate research, teaching and other academic work;
 - (5) to make statutes and approve rules and regulations;
 - (6) to have prepared and revised from time to time rules and regulations for the efficient and effective operation of the Institute;
 - (7) to create a component of the Institute such as faculties, departments and institutes under its jurisdiction and to constitute such standing committees, councils and other administrative or academic advisory bodies as it deems necessary, and review their work;
 - (4) to consider plans of work and annual budget of the Institute for approval;
 - (9) to call for and consider reports relating to the activities of the Institute and the execution of the plans of work and to direct the Rector to furnish information relating to any matter specified by the Board;
 - (10) to create such academic or administrative posts as it may deem necessary and to approve appointment to such posts;
 - (11) to constitute committees or sub-committees as it may deem necessary;
 - (12) to take all such initiatives as it may consider necessary for the efficient and effective management and functioning of the Institute;

- (13) to appoint teachers and other employees in BPS-17 and above on the recommendation of the Selection Board; and
- (14) to delegate its powers to an authority or officer including the Rector or a Committee.
- (1) The Board shall meet at least twice a year on the dates to be fixed by the Proctor, with the approval of the Chairman;

Provided that a special meeting may be called at any time by the Chairman on the request by not less than five members of the Board to consider any matter of urgent nature.

- (2) In the case of a special meeting not less than len clear days notice shall be given to the members of the Board, and the agenda of the meeting shall be restricted to the matter for which the special meeting is called.
- (3) The quorum for a meeting of the Board shall be one half of its members, fraction being counted as one.
- (4) The decisions of the Board shall be expressed in terms of the views of the majority and voting of the members present and if the members are equally divided, the Chairman shall have the power to exercise a casting vote.

The academic and administrative staff of the Institute shall be selected with a view to achieving its objectives and the basic criteria for their selection shall be the highest standards of competence, integrity and efficiency:

Provided that in the case of academic staff, academic qualification and fringe benefit shall not be less than those approved or laid down by the Cammission for such staff.

(1) institute shall have a Fund to which shall be credited income from fees, donations, trusts, bequests, endowments, grants, contribution and any other source.

(2) No contribution, donation or grant, which may directly or indirectly involve any immediate or subsequent financial liability of the institute or which may involve an activity not included in its programmes for the time being shall be accepted without the prior approval of the Board.

(3) The accounts of the Institute shall be maintained in such form and in such manner as may be prescribed by rules.

- (4) The accounts of the Institute shall be audited each year within four months of the closing of the financial year by a Chartered Accountant appointed by the Board.
- (5) The accounts, together with the report of the auditor thereon, shall be submitted to the Board for approval.

Meeting of the Board.

Academic and administrative staff.

Institute funds, audit and accounts.

- (6) The auditor's report short contry that the auditor has complied with the standards of audit and certification laid down by the institute of the Chartered Accommissis of Pakistan.
- The Academic Council. 18. (1) The Academic Council shall consist of -
 - (a) the Rector who shall be the Charmon;
 - (b) till the Deanst
 - (c) all the Heads of the Teaching Departments,
 - (d) A Professors and Associate Professors of the Institute:
 - a nominee of the Education Secretary not below the rank of Deputy Secretary, the Executive District Officer (Education) and the Executive District Officer (Technical) concerned;
 - (f) two Assistant Professors and two Lecturers nominated by the Board;
 - (g) three persons emirrent in the arts, the sciences and the professionals one from each datagory nominated by the Board;
 - (h) Advisor (Academics) of the Commission, or his numinee; and
 - (i) the Registrar who shall act as its secretary.
 - (2) Members appointed by nomination shall hold office for a period of three years.
 - (3) The quorum for a meeting of the Academic Council shall be one-third of the total number of members, a fraction being counted as one.

Powers and duties of the Academic Council. 19.

- (1) The Academic Council shall be the academic body of the Institute and shall, subject to the provisions of this Act and the statutes, have the powers to lay down proper standards of instructions, research, publication extrainations and to regulate and promote the academic life of the Institute.
- (2) Without prejudice to the generality of the foregoing powers and subject to the provisions of this Act and the statutes, the Academic Council shall have the powers to —
 - (a) advise the Board on academic matters;
 - and required the conduct of teaching, research, publication and
 - (c) regulate the admission of students to the courses of studies and examinations in the Institute;
 - (d) regulate the conduct and discipline of the students of the Institute,

- (e) propose to the Board scheme for the constitution and organization of the Faculties and Teaching Departments;
- (f) consider and formulate proposals of feaching and research in the Institute for the Planning and Development:
 - (g) prescribe the course of studies, the syllabil and the outlines of tests for all examinations, subject to the approval of the Board;
 - (h) regulate the award of studentships, scholarships, exhibitions, medals and prizes:
 - (i) frame regulations with the approval of the Board;
 - appoint or nominate members to the various Authorities in accordance with the provisions of this Act, and
 - (k) perform such other functions as may be prescribed by the statutes.
- 20. (1) The constitution functions and the powers of the Authorities for which no specific provision has been made in this Act shall be such as may the prescribed by statutes.

Constitution, renetions and powers of other Authorities.

- (2) The Authorities may with the approval of the Board, make rules consistent with this Act, statutes and regulations
- 21. The Board, the Academic Council and other Authorities may from times to time appoint such standing, special or advisory committees as they deem fit and may nominate such persons on these committees who are not members of the authorities appointing the committees.

Appointment of committees by the Authorities.

22. (1) The insulate shall work within the framework of the Education Policy and other law or policy framed by Government or the Commission from time to time.

General Provision.

- (2) The academic qualifications, salary and tringe banefits of the academic staff shall not be less than those admissible to such staff in public Universities in the Province
- (3) Armual Monitoring charges as fixed by Government from time to time shall be paid by the institute through a pay order in the name of the Secretary Education, Government of Sindly.
- (4) Where this Act makes any provision for anything to be done but no provision or no sufficient provision has been made in respect of the Authority by whom, the time at which, or the manner in which, it shall be done, then it shall be done by such Authority, at such time, or in such manner as the Chairman may direct.

- Interpretation.
- If any question arises as to the interpretation of any of the provisions of this Act, it shall be placed before the Patron whose decision thereor shall be final.
- Removal of difficulties.

If any difficulty arises in giving effect to any of the provisions of this Act the Chairman may make such order, not inconsistent with the provisions of this Act as may appear to him to be necessary for removing the difficulty.

First Statutes.

Notwithstanding anything to the contrary contained in this Act, the Firs Statutes shall be deemed to be the statutes framed under this Act and shall continue to remain in force until amended, repealed or new statutes are framed in accordance with the provisions of this Act.

The First Statutes (See section 25)

The Faculties.

- The Institute shall include the following faculties and such other faculties as may be prescribed: —
 - (1) Faculty of Management Sciences, and
 - (2) Faculty of Information Technology and Computer Sciences.

Board of Faculty.

- 2. (1) There shall be a Board of each Faculty, which shall consist of -
 - (a) The Dean;
 - (b) the Professors and the Heads of the Teaching Departments;
 - (c) one member other than Professors and Head of the Teaching Department nominated by the Board;
 - (d) two teachers to be nominated by the Academic Council by reasor of their specialized knowledge of the subjects which, though no assigned to the faculty, but has in the opinion of the Academic Council important bearing on the subjects assigned to the Faculty;
 - (e) two experts in the relevant field from outside the Institute to be nominated by the Board; and

(f) one member to be nominated by the Rector.

3.

- (2) The members other than ex-officio members shall hold office for a period of three years.
- (3) The quorum for a meeting of the Board of a Faculty shall be one-half of the total number of members, a fraction being counted as one.
- The Board of Faculty shall, subject to the general control of the Academic Council and the Board have the powers to –

Functions of the Board of Faculty.

- (a) co-ordinate the teaching and research work in the subjects assigned to the Faculty;
- the Faculty with regard to the appointment of paper-setters and examiners for graduate and post graduate examinations and to forward the paper of suitable paper-setters and examiners for each commitmation to the Rector:
- - 1) prepare a comprehensive annual report regarding the performance of acn repartment, comprising the faculty for presentation to the recodemic Council and
- (a) perform such other functions as may be prescribed by statutes.
- There shall be a Dean of each Faculty who shall be the Chairman and Convener of the Board of Faculty.

The Dean.

- (2) The Dean shall be appointed by the Board from amongst the three most senior Professors of the Faculty on the recommendations of the Rector and shall hold office for a period of three years and shall be eligible for re-appointment.
- (3) The Dean shall have such powers and duties as may be prescribed by the Board on the recommendations of the Rector.
- There shall be a Teaching Department for each subject or a group of subjects as may be prescribed by regulations and shall be headed by a Head of Department.

Teaching Departments and Head of the Department.

(2) The Head of a Teaching Department shall be appointed by the Board on the recommendations of the Rector from amongst three senior most Professors or Associate Professors other than Professors already working as Deans for a period of three years and shall be eligible for reappointment:

Provided where in, a Department, there is no Professor or Associate Professor, no such appointment shall be made and the Department shall be looked after by the Dean with the assistance of the senior most teacher of the Department.

- (3) The Head of the Teaching Department shall -
 - (a) plan, organize and supervise the work of the department and shall be responsible to the Dean for the work of his Department;
 - (b) under the general supervision of the Rector and the Dean, exercise all administrative, financial and academic powers and such other

duties or powers as may be delegated to him; and

- (c) prepare a comprehensive annual report on the performance of the Department at graduate and post-graduate levels, faculty research and development and submit it to the Dean for evaluation.
- 6. (1) the bound of Advanced Studies and Research shall consist of -

Board of Advanced Studies and Research.

- (a) the Rector as its Chairman;
- (b) all Deans.
- (c) one Professor from each faculty having experience in research in relevant field to be nominated by the Academic Council;
- (d) one Professor from each faculty other than the Dean to be nominated by the Board;
- (e) one member to be nominated by the Rector;
- (f) three members from the relevant field from the Research Organizations and Government Departments to be nominated by the Board; and
- (g) the Registrar, who shall act as its Secretary.
- (2) The term of office of the members of the Board of Advanced Studies and Research, other than ex-officio members, shall be for a period of three years.
- (3) The quorum for a meeting of the Board of Advanced Studies and Research shall be one-half of the total number of members, a fraction being counted as one.
- 7. The functions of the Board of Advanced Studies and Research shall be

Functions of Board of Advanced Studies and Research.

- (a) advise the Authorities on all matters connected with the promotion of advanced studies, research and publications in the Institute;
- (b) consider and report to the Authorities on the institution of research degrees in the institute;

- (c) propose regulations regarding the award of research degree;
- (d) appoint supervisors for post graduate research students and to approve titles and synopsis of their thesis or dissertations;
- recommend panels of names of examiners for evaluation of their thesis and other research examinations; and
- (f) perform such other functions as may be prescribed by statutes.
- (1) The Selection Board shall consist of -

Selection Board.

- II The Rector, who shall be the Chairman;
- (b) the Dean of the concerned Faculty:
- (c) the Head of the concerned Teaching Department;
- (d) one member of the Board to be nominated by the Board;
- (e) one eminent scholar to be nominated by the Board, and
- (f) one subject expert to be nominated by the Board.
- (2) The Registrar shall be the Secretary of the Selection Board
- (3) The members other than ex-officio members shall hold office for a period of three years.
- (4) The quorum for a meeting of the Selection Board shall be four.
- No member who is a candidate for the posts to which appointment is to mare that take part in the proceedings of the Selection Board.
- (6) Committing candidates for the posts of Professors and Associate Frofessors, the Selection Board shall co-opt or consult three experts in the subject concerned and in selecting candidates for other teaching posts two experts in the subject concerned, to be nominated by the Rector from a standing list of experts to be revised from time to time for each subject approved by the Board on the recommendations of the Sulection Board.
- 9. (1) The Selection Board, for other teaching staff and other officers and officials, shall consider the applications and recommend to the Board of Governor, the names of suitable candidates for appointment and recommend suitable salary for the person concerned.
 - (2) The Selection Board, shall consider all cases of promotion or selection of officers of the Institute and recommend the names of suitable candidates for such promotion or selection to the Board

Functions of Selection Board. (3) In the event of an unresolved difference of opinion between the Selection Board and the Board the decision of the Board shall be final.

The Finance and Planning Committee.

- 10. (1) The Finance and Planning Committee shall consist of -
 - (a) The Rector, who shall be the Chairman;
 - (b) all the Deans:
 - (c) one member of the Board nominated by the Board:
 - (d) one nominee of the Commission:
 - (e) one member of the Academic Council nominated by the Academic Council;
 - (f) one representative each from Education Department and Finance
 Department not below the rank of Deputy Secretary; and
 - (g) Treasurer, who shall act as Secretary.
 - (2) The term of office of the nominated members shall be for a period of three years.
 - (3) The quorum for a meeting of the Finance and Planning Committee shall be five members.

Functions of the Finance and Planning 11. Committee.

The functions of the Finance and Planning Committee shall be to -

- (3) prepare the annual statement of accounts, propose annual budget estimates and advise the Board thereon;
- (b) review periodically the financial position of the Institute;
- (c) advise the Board on all matters relating to finance, investments and accounts of the Institute; and
- (d) perform such other functions as may be prescribed under statutes.
