PROVINCIAL ASSEMBLY OF SINDH NOTIFICATION

Karachi, the 11th October, 2004

NO.PAS/LEGIS-B-2/2004-. The Sindh Information Technology Board (Amendment) Bill, 2004 having been passed by the Provincial Assembly of Sindh on 18th August, 2004 and assented to by the Governor of Sindh on 6th October, 2004, is hereby published as an Act of the Legislature of Sindh.

THE SINDH INFORMATION TECHNOLOGY BOARD (AMENDMENT) ACT, 2004.

SINDH ACT NO.XII OF 2004

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 11th October, 2004).

> AN ACT

to amend the Sindh Information Technology Board Ordinance, 2002

Preamble

WHEREAS it is expedient to amend the Sindh Information Technology Board Ordinance, 2002, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- Short title and commencement
- (1) This Act may be called the Sindh Information Technology Board (Amendment) Act, 2004.
- (2) It shall come into force at once.

Amendment of Section 2 of Sindh Ordinance No.III of 2002.

- 2. In the Sindh Information Technology Board Ordinance, 2002, hereinafter referred to as the said Ordinance, in section 2
 - (i) after clause (c), the following new clause shall be inserted:-
 - "(cc) "Member" means a member of the Board:
 - (ii) In clause (f), the full stop at the end shall be replaced by a semi colon and thereafter the following new clause shall be added:-
 - "(g) "Vice Chairperson" means the Vice Chairperson of the Board."

Amendment of section 4 of Sindh Ordinance No. III of 2002.

- 3. In the said Ordinance, in section 4, for sub-section (1), the following shall be substituted:-
 - "(1) The Board shall consist of -
 - (i) Governor of Sindh

Chairperson

- (ii) Minister for Information Technology Vice-Chairperson or in his absence any person nominated by the Chief Minister.
- (iii) Eleven members at least five of whom shall be from private sector to be appointed by Government."
- 4. In the said Ordinance, in section 5, in sub-section (2), for clause (a), the following shall be substituted:-

Amendment of section 5 of Sindh Ordinance No.III of 2002 "(a) promote or develop use of information technology and its strategy on the pattern of National Information Technology Policy, if any;".

Amendment of section 7 of Sindh Ordinance No.III of 2002.

- In the said Ordinance, in section 7, for sub-section (2), the following shall be substituted:-
 - "(2) The Chairperson may also delegate any of his powers other than the powers of the Board delegated to him to any officer of the Board."

Repeal

The Sindh Information Technology Board (Amendment) Ordinance, 2003 is hereby repealed.
