No. PAS/Legis-B-13/96.—The People's Medical College and Hospital Nawabshah (Amendment) Bill, 1996 having been passed by the Provincial Assembly of Sindh on 22nd August, 1996 and assented to by the Governor of Sindh on 16th September, 1996 is hereby published as an Act of the Legislature of Sindh.

to amend the People's Medical College and Hospital Nawabshah Act, 1995.

WHEREAS it is expedient to amend the People's Medical College Preamble and Hospital Nawabshah Act, 1995, in the manner hereinafter appearing;

Short title and Commencement

It is hereby enacted as follows: -

- 1. (1) This Act may be called the People's Medcial College and Hospital Nawabshah (Amendment) Act, 1996.
 - (2) It shall come into force at once.

Amendment of section 18 of the Sindh Act XIII of 1995

- 2. In the People's Medical College and Hospital, Nawabshah Act, 1995, in section 18:-
 - (1) for sub-section (2), the following shall be substituted:— "(2) The option under sub-section (1) shall be made, and submitted to Government within ninety days of the commencement of the People's Medical College (Amendment Act, 1996"
 - (2) in sub-section (3), for word "Government", the words "the Board" shall be substituted.
 - (3) after sub-section (3), the following new sub-section shall be added:-
 - "(4) Where the services of a person who has not made an option under sub-section (2) are required in the public interest by the Medical College, such person shall, notwithstanding the terms and conditions of his service be transferred to the Medical College and on such transfer he shall be deemed to be on deputation on the terms and conditions as Government may determine"
