It is hereby enacted as follows:-

Short title and commencement

HETEROTED SHE

- 1. (1) This Act may be called the Sindh Service Tribunals (Second Amendment) Act, 1994.
 - (2) It shall come into force at once.

Amendment of Section 2 of sind Act XV 197'

- 2. In the Sind Service Tribunals Act, 1973, in section 2, after clause (b), the following shall be inserted:—
 - "(bb) "member of the subordinate judiciary" means a District and Sessions Judge, Additional District and Sessions Judge, Senior Civil Judge and Assistant Sessions Judge, Civil Judge and Judicial Magistrate and includes an officer and servant of the High Court or an employee working under the administrative control of the District and Sessions Judge wherever he may be."
