No. PAS/Legis-B-2/92.—The Land Acquisition (Sindh Amendment) Bill, 1992 having been passed by the Provincial Assembly of Sindh on 16th September, 1992 and assented to by the Governor of Sindh on 23rd November, 1992 is hereby published as an Act of the Legislature of Sindh.

SINDH ACT NO. VIII OF 1992

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 1st December, 1992).

to amend the Land Acquisition Act, 1894, in its application to the Province of Sindh.

WHEREAS, it is expedient to amend the Land Acquisition Act, 1894, Preamble in its application to the Province of Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Land Acquisition (Sindh Amendment) Act, 1992.
 - (2). It shall come into force at-once.

Amendment of section 18 of Act x of 1894

2. In the Land Acquisition Act, 1894, in its application to the Province of Sindh, hereinafter referred to as the said Act in section 18, in subsection (3), for the words "the Provincial Government", the words and commas "The Federal Government, the Provincial Government, a Company or a local authority, as the case may be," shall be substituted.

Amendment of section 20 of Act X of 1894. 3. In the said Act, in section 20, in clause (c), for the words "and the Department of Government", the words and comma "the Federal Government, the Provincial Government" shall be substituted.

Amendment of section 22-A of Act X of 1894. 4. In the said Act, in section 22-A, for the words and comma "The Provincial Government" the words "The Federal Government or the Provincial Government" shall be substituted.

Amendment of section 31 of Act X of 1894. 5. In the said Act, in section 31, in sub-section (1), for the words "the Provincial Government" wherever occurring, the words and commas "the Federal Government or the Provincial Government, as the case may be", shall be substituted.

Amendment of section 50 of Act X of 1894. 6. In the said Act, in section 50, in sub-section (2), the colon may be replaced by the full stop and the proviso shall be deleted.

1894. Repeal of Sindh Ordinance No. IV of 1992 7. The Land Acquisition (Sindh Amendment). Ordinance, 1992 is hereby repealed.
