No. PAS/Legis-B-15/89.—The Sindh Local Government (Second Amendment) Bill, 1989 having been passed by the Provincial Assembly of Sindh on 4th December, 1989 and assented to by the Governor of Sindh on 4th January, 1990 is hereby published as an Act of the Legislature of Sindh.

SINDH ACT NO. III OF 1990

(First published after having received the assent of the Governor of Sindle in the Gazette of Sindh (Extra-Ordinary) dated 16th January, 1990).

ACT

to amend the Sind Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sind Local Geverament Ordi- Preamble. nance, 1979, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement

- 1. (1) This Act may be called the Sindh Local Government (Second Amendment) Act. 1989.
 - (2) It shall come into force atonce.

Amendment of Sind a Ordinance

2. In the Sind Local Government Ordinance, 1979, hereinafter referof section 14 red to as the said Ordinance, in section 14, in sub-section (1), in clause (b), the full-stop at the end shall be replaced by a semi-colon and thereafter the XII of 1979, following proviso shall be added:

> "Provided that a person other than a woman who contested election but lost on a general seat shall not be eligible to contest election under this clause.

Amendment of section 33 of Sind Ordinance XII of 1979.

- 3. In the said Ordinance, section 33 shall be re-numbered as sub-section (1) of that section and after sub-section (1) as so re-numbered, the following sub-section shall be added:-
 - "(2). The Election Authority shall have a Secretariat manned by the officers and staff recruited by the Authority according to law for the time being in force.".

Amendment | of section 37 of Sind Ordinance XII of 1979.

- 4. In the said Ordinance, in section 37, in sub-section (2)—
 - (i) in clause (c), the words "or is physically incapacitated" shall be deleted:
 - (ii) in clause (d), between the word "offence" and "coma" the words "involving moral turpitude" shall be inserted.
