NO.PAS/Legis-B-26/2012-The Sindh Revenue Board (Amendment) Bill, 2012 having been passed by the Provincial Assembly of Sindh on 21st February, 2013 and assented to by the Governor of Sindh on 27th February, 2013 is hereby published as an Act of the Legislature of Sindh.

THE SINDH REVENUE BOARD (AMENDMENT) ACT, 2012.

SINDH ACT NO. VII OF 2013.

AN ACT

to amend the Sindh Revenue Board Act, 2010.

WHEREAS it is expedient to amend the Sindh Revenue Preamble. Board Act, 2010, in the manner hereinafter appearing;

It is hereby enacted as follows:-

 (1) This Act may be called the Sindh Revenue Board Short title and (Amendment) Act, 2012.

Short title and commencement.

- (2) It shall come into force at once.
- 2. In the Sindh Revenue Board Act, 2010, hereinafter referred to as the said Act, in section 3 Section 3 of Sin

Amendment of Section 3 of Sindh Act No.XI of 2010.

- (i) for sub-section (3), the following shall be substituted:-
 - "(3) Government may appoint or nominate any person as the Chairman or a member on such terms and conditions and for such period as it may determine; and
- (ii) In sub-section 8, for the word "Government", the word "Board" shall be substituted.
- 3. In the said Act, in section 5, after sub-section (2), the Amendment of following new sub-section (3) shall be added:-

"(3) Notwithstanding anything contained in this Act or any other law, rules or judgment of any court, the Board shall be competent to redesignate or regularize its existing employees working on contract or temporary basis, in basic pay scales 1 to 20, through a Selection Committee to be notified by Government or, as the case may be, the Board and Government or Board shall not be required to refer such employees to and consult the Sindh Public Service Commission for making such appointments or on matters relating to qualifications for such appointment and methods of their recruitment."

Amendment of Section 5 of Sindh Act No.XI of 2010.

- 4. In the said Act, in section 6
 - in sub-section (1), after clause (v), the following new clause shall be inserted:-

"(v-a) Secretary, Government of Sindh, Law Department;";

(ii) in sub-section (2), for the words "two members" the words "not exceeding four members" shall be substituted.

5. In the said Act, after section 10, the following new section 10-A shall be added:-

"10-A. All the Government departments, autonomous bodies, corporations established or controlled by Government shall provide necessary assistance and support to the Officers of the Board in carrying out the functions under this Act."
