SINDH ORDINANCE NO. I OF 2002

ORDINANCE

WHEREAS it is expedient to amend the Sindh Local Government Ordinance, 2001, in the Manner hereinafter appearing;

preemble.

AND WHEREAS the provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999 and the Provisional Constitution Order No. 1 of 1999;

AND IMEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOM, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and 1. commencement.

- (1) This Ordinance may be called the Sindh Local Government (Third Amendment) Ordinance, 2001.
- It shall come into force at once and shall be deemed to have taken effect on and from 14th August, 2001.
