SINDH ORDINANCE NO .: VI OF 2002

AN ORDINANCE

to amend the Sindh Irrigation and Drainage Authority Act, 1997.

WHEREAS it is expedient to amend the Sindh Irrigation and Drainage Authority Act, 1997, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitutional Order No. 1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commencement.

- 1. (1) This Ordinance may be called the Sindh Irrigation and Drainage Authority (Amendment) Ordinance, 2002.
 - (2) It shall come into force at once .

Amendment of 2. In the Sindh Irrigation and Drainage Authority Act 1997, hereinafter section 4 of Sindh referred to as the said Act, in section 4, in sub-section (1), for clause (h), the Act No. IV of . following shall be substituted:

"(h) Five representatives of Farmers: Organizations three from Sukkur Barrage Command and one each from Gudu Barrage Command and Kotri Barrage Command; provided that where Farmers Organizations are not formed such members may be selected by the Authority.".

Amendment of section 23 of Sindh Act No. IV of 1997. 3. In the said Act, in section 23, in sub-section (2), in clause (a), for the word "Two", the word "Four", shall be substituted.

Amendment of section 26 of Sindh Act No. IV of 1997. In the said Act, in section 26, the words "Bye-Laws" shall be omitted.
