SINDH LOCAL GOVERNMENT (FIFTH AMENDMENT) ORDINANCE, 2002.

Sindh Ordinance No. XXV of 2002

to further amend the Sindh Local Government Ordinance, 2001.

WMEREAS it is expedient to amend the Sindh

Local Covernment Ordinance, 2001, in the manner hereinafter appearing;

AND MIERRAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. 1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid proclamation and the Provisional Constitution Order read with Provisional Constitution ("mendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Overnor of Sindh is pleased to make and promulgate the following Ordinance:—

- Short title and 1. (1) This Ordinance may be called the Sindh Local commencement. Overnment (Fifth Amendment) Ordinance, 2002.
 - (2) It shall come into force at once.

Amendment of 2. In the Sindh Local Government Ordinance, 2001, section 158 of Sindh Ordinance hereinafter referred to as the said Ordinance, for No.XXVII of 2001. section 158, the following shall be substituted:

"158. Bar Against Nazims for dual membership, etc.—A Zila Nazim, Naih Zila Nazim, Taluka Nazim, Naih Taluka Nazim, Town Nazim, Naih Town Nazim, Union Nazim and Naib Union Nazim may contest election for any other political office after resigning from the existing office of Nazim, or, as the case may be, Naib Nazim;

Provided that a member of Zila Council, Taluka Council, Town Council or Union Council may contest election for any other political office without resigning from the membership of such Council;

Provided further that such member shall not hold more than one office at one time.".
