THE SINDH LOCAL GOVERNMENT ELECTION'S (AMENDMENT) ORDINANCE 2001

SINDH ORDINANCE NO.X IX OF 2001

ORDINANCE

to amend the Sindh Local Government Elections Ordinance,

WHEREAS, it is expedient to amend the Sindh Local Government Elections Ordinance, 2000, in the manner hereinafter appearing.

Preamble.

2000.

AND WHEREAS, in pursuance of the Proclamation of Emergency dated 14th October, 1999, and under Article 3 (2) of the Provisional Constitution Order No. 1 of 1999, dated 14th October, 1999, the Governor of a Province is to act on the instructions of the Chief Executive:

AND WHEREAS, under Article 4 of the Provisional Constitution (Amendment) Order No. 9 of 1999, the Governor of a Province may, on the instructions of the Chief Executive of Pakistan, issue and promulgate an Ordinance;

AND WHEREAS, under the Local Government Elections Order, 2000 (No. 8 of 2000), the Chief Executive of Pakistan has been pleased to empower the Chief Election Commissioner to conduct local government elections in the Provinces;

AND WHEREAS, the Governor is satisfied that circumstances exist which render it necessary to take immediate action:

NOW, THEREFORE, in exercise of the aforesaid powers and all other powers enabling him in this behalf, the Governor of the Sindh Province, on the instructions of the Chief Executive of Pakistan, is pleased to make and promulgate the following Ordinance:- ALVOD

This Ordinance may be called the Sindh Local Short title and (1) commencement, Government Elections (Amendment) Ordinance, 2001.

It shall come into force at once. (2)

Amendment of 2. Sindh Ordinance No. X of 2000

In the Sindh Local Government Elections Ordinance, 2000, in section 10 of section 10, after sub-section (3) the following Explanation shall be added, namely,-

"Explanation .- For the purpose of this section, all members of the union councils notified as returned candidates in the elections held under this Ordinance shall be deemed to be members of the electoral college.".
