THE SINDH URBAN STATE LAND (CANCELLATION OF ALLOTMENTS, CONVERSIONS AND EXCHANGES)(AMENDMENT) ORDINANCE 2001.

SINDH ORDINANCE NO. XXX III OF 2001

AN
ORDINANCE

to amend the Sindh Urban State Land (Cancellation of Allotments, Conversions and Exchanges) Ordinance , 2001.

Preamble

WHEREAS it is expedient to amend the Sindh Urban State Land (Cancellation of Allotments, Conversions and Exchanges) Ordinance, 2001 in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999 and the Provisional Constitution Order No.1 of 1999;

AND WHEREAS, the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance : -

Short title and commencement.

1. (1) This Ordinance may be called the Sindh Urban State Land (Cancellation of Allotments, Conversions and Exchanges) (Amendment) Ordinance, 2001.
- (2) It shall come into force at once and shall always be deemed to have taken effect on and from 3rd January, 2001.

In the Sindh Urban State Land (Cancellation of All Rights, Conversions and Exchanges) Ordinance, 2001 (hereinafter referred to as the said Ordinance, for

the words "urban state land" wherever occurring, the words "Government land" shall be substituted.

3. In the said Ordinance, in section 3, for the words "shall stand cancelled", the words "including the subsequent transaction in respect thereof shall stand cancelled" shall be substituted.

4. In the said Ordinance, in section 5, between the word "paid" and the word "shall", the words "and are free from all encumbrances" shall be inserted.

Amendment of section 5 of Sindh Ordinance No. III of 2001.
