ORDINANCE

to amend the Sindh Public Service Commission Act, 1989

WHEREAS. it is expedient to amend the Sindh Public Service Preamble. Commission Act, 1989. in the manner hereinafter appearing;

AND WHEREAS, the Provincial Assembly is not in session and the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action.

NOW THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the constitution of the Islamic Republic of Pakistan, the Governor of Sindh is pleased to make and promulgate the following Ordinance: -

Short title and commencement.

- (1) This Ordinance may be called the Sindh Public Service Commission (Amendment) Ordinance, 1999.
 - (2) It shall come into force at once.
- In the Sindh Public Service Commission Act. 1989 for section 5-A. the following shall be substituted:—

Amendment. of section 5-A of Sindh Act. XI of 1989.

"5-A Notwithstanding anything contained in this Act. Government may, not later than 30th September, 1999 curtail the term of Office of the Chairman and members appointed before the coming into force of this section".

Preamble.

WHEREAS it is expedient to amend the Sindh Public Service Commission Act, 1989, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly is not in session and the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commence-

- (i) This Ordinance may be called the Sindh
 Public Service Commission (Amendment)
 Ordinance, 1999.
 - (ii) It shall come into force at once.

Amendment of certain sections of Sindh Act XI of 1989 2. In the Sindh Public Service Commission
Act, 1989, hereimafter referred to as the said Act,
in section 3, in section 4, in sub-section (1) of
section 5 and/section 9, for the word "Government",
the word "Governor" shall be substituted.

Addition of section 5-B in Act XI of 1989.

Ji. In the said Act, after section 5-A, the following new section shall be inserted:-

"5-B.
Appointment 8
of honorary
members

- (1) Notwithstanding anything contained in this Act, the Governor may appoint XXXX such number of honorary members for such period not exceeding ninety days on payment of such honorarium as the Governor may determine.
- (2) The honorary member shall assist the Commission in performance of its functions under this Act.

- (3) The honorary member may, unless removed earlier, resign his office by addressing a letter to the Governor.
- 4. In the said Act, in section 6 -
 - (a) in sub-section (1) and (2), for the word "Government", the word "Governor" shall be substituted;
 - (b) in the Explanation, for the word "Government" occuring for the first time, the word "Governor" shall be substituted.
