## THE SIND CHILDREN (AMENDMENT) ORDINANCE, 1984.

Sind Ordinance No. IX of 1984

### AN

#### ORDINANCE

to amend the Sind Children Act, 1955.

WHEREAS the Federal Shariat Court has directed to make certain Preamble, amendments in the Sind Children Act, 1955;

AND WHEREAS it is expedient to amend the Sind Children Act, 1955, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

Short Title and commencement.

- 1. (1) This Ordinance may be called the Sind Children (Amendment) Ordinance, 1984.
  - (2) It shall come into force at once,

Omission of section 14 of Sind Act XII of 1955.

2. In the Sind Children Act, 1955, hereinafter referred to as the said Act, section 14 shall be omitted.

Amendment of section 90 of Sind Act XII of 1955.

- 3. In the said Act, in section 90—
  - (a) in sub-section (4), for the words "his putative father", the words "the state" shall be substituted;
  - (b) in the proviso to sub-section (4), for the words "putative father" the word "state" shall be substituted.

to amend the Prisoners Act, 1900.

WHEREAS the Federal Shariat Court has directed to make certain Preamble, amendments in the Prisoners Act, 1900;

AND WHEREAS it is expedient to amend the Prisoners Act, 1900, in its application to the Province of Sind, in the manner hereinafter appearing,

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

Short title and commencement.

- 1. (1) This Ordinance may be called the Prisoners (Sind Amendment) Ordinance, 1984.
  - (2) It shall come into force at once.

Amendment of section 40 of Act III of 1900.

2. In the Prisoners Act, 1900, in its application to the Province of Sind, in section 40, the commas and the words ",if it thinks fit," shall be deleted.
