Karachi, the 3rd June, 1987

No. PAS/Legis-B-4/87.—The Sind Medical Colleges Bill, 1987 having been passed by the Provincial Assembly of Sind on 27th April, 1987 and assented to by the Governor of Sind on 25th May, 1987 is hereby published as an Act of the Legislature of Sind.

# THE SIND MEDICAL COLLEGES ACT, 1987

SIND ACT NO. V OF 1987

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary) dated 3rd June, 1987).

#### AN

#### ACT

to regulate admissions in the medical colleges in Sind and other ancillary matters including the conduct and discipline of the students of such colleges.

WHEREAS it is expedient to regulate admissions in the medical Preamble. colleges in Sind and other ancillary matters including the conduct and discipline of the students of such colleges;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sind Medical Colleges Act, 1987.
  - (2) It extends to all medical colleges in Sind.

Short title and commencement.

(3) It shall come into force at once.

Definitions.

- 2. In this Act, unless there is anything repugnant to the subject or context—
  - (a) "Government" means the Government of Sind;
  - (b) "medical college" means a medical college established or maintained and run by Government and includes a dental college;
  - (c) "rules" means the rules framed under this Act;
  - (d) "student" means a student of a medical college.

Power of Government to make reles,

- 3. (1) Notwithstanding anything contained in any law, for the time being in force, but subject to the Medical Councils Ordinance, 1962, Government may by rules—
  - (a) regulate admissions in a medical college;
  - (b) supervise and control discipline of students;
  - (c) institute, maintain and control halls of residence and approve any place as hostel or lodging for students.
- (2) Without prejudice to the generality of the foregoing provisions, the rules may provide for—
  - (a) allocation of seats;
  - (b) form of application for admission;
  - (c) conditions for admission;
  - (d) conditions for and procedure of migration;
  - (e) disciplinary action against and imposition of penalty on students:
  - (f) institution and maintenance of and conditions for admission to the residential halls and hostels.

Repeal of Sind Ordinance II of 1987. 4. The Sind Medical Colleges Ordinance, 1987 is hereby repealed.
