NOTIFICATION

Karachi, the 10th December, 1987

No. PAS/Legis-B-8/87.—The Sind Urban Immovable Property Tax (Amendment) Bill, 1987 having been passed by the Provincial Assembly of Sind on 26th October, 1987 and assented to by the Governor of Sind on 24th November, 1987 is hereby published as an Act. of the Legislature of Sind.

THE SIND URBAN IMMOVABLE PROPERTY TAX (AMENDMENT) ACT, 1987

SIND ACT NO. VIII OF 1987

(first published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary) dated 10th December 1987).

AN

ACT

to amend the Sind Urban Immovable Property Tax Act, 1958.

WHEREAS it is expedient to amend the Sind Urban Immovable Preamble, roperty Tax Act, 1958, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sind Urban Immovable Property
Tax (Amendment) Act, 1987.

Short title and commensement,

Amendment of section Pakistan Act V of 1958.

- 2. In the Sind Urban Immovable Property Tax Act, 1958 hereinafter 7-A of West referred to as the said Act, in section 7-A-
 - (a) in clause (i) the word "and" at the end shall be omitted:
 - (b) in clause (ii), the full-stop at the end shall be replaced by a semicolon and thereafter, the following new clause shall be inserted :-

"(iii) The valuation lists made on 1st January, 1977, in respect of the properties used wholly or partly for industrial purposes shall continue to be in force from the said date and be the basis of levying the tax until the date on which the new lists are enforced in accordance with the provisions of section 7.20.

3. In the said Act, for section 8-A, the following section shall be Amendment substituted:of section

3-A of West Pakistan Act V of 1958.

Notwithstanding anything contained in this Act or 8-A-Validation. judgement, order or decree of any court, the valuation lists which have been prepared in respect of the properties used wholly or partly for industrial purposes and situated within the limits of the Rating Areas of the Karachi Division and have been enforced from the 1st day of January, 1977, shall always be deemed to have been validly prepared and enforced and the tax levied, charged, collected or realized in pursuance of such lists shall always be deemed to have been validly levied, charged, collected realized.

Repeal of Sind Ordinance VI of 1987.

The Sind Urban Immovable Property Tax (Amendment) Ordinance, 1987 is hereby repealed.
