No. S.Legis. 1(29)/84.—The following Ordinance by the Governor of Sindh is hereby published for general information:—

### THE SIND LOCAL GOVERNMENT (AMENDMENT) ORDINANCE, 1984.

Sindh Ordinance No. XXIX of 1984.

AN

ORDINANCE

*to amend the Sindh Local Government Ordinance, 1979.*

WHEREAS it is expedient to amend the Sindh Local Government Ordinance, 1979, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor or Sindh is pleased to make and promulgate the following Ordinance:—

1. (1) This ordinance may be called the Sindh local Government (Amendment) Ordinance, 1984.

(2) It shall come into force at once except section 2, which shall be deemed to have taken effect from Kharif, 1984.

Amendment  
of section 59  
of Sind Ordinance  
XII of 1979.

2. In the Sind Local Government Ordinance, 1979, hereinafter referred to as the said Ordinance, in section 59, for sub-section (2), the following shall be substituted:—

“(2) Government may, from time to time, by notification in the official gazette, fix the rate of local cess for various classes of cultivated land in a district.”

3. In the said Ordinance, in Schedule II, in Part II—

(a) under the heading “COMPULSORY FUNCTIONS”, after paragraph 12, the following sub-heading and new paragraph shall be added:—

#### EDUCATION

13. A corporation, municipal committee, or town committee shall take such measures as may be necessary for promotion of adult education.”;

(b) under the heading “OPTIONAL FUNCTIONS”, in paragraph 61, clause (d) shall be omitted.

4. In the said Ordinance, in Schedule III—

(a) in Part I, under the heading “COMPULSORY FUNCTIONS”, after paragraph 14, the following new paragraph shall be inserted:—

“14-A. To promote adult education.”;

(b) in Part II, under the heading “OPTIONAL FUNCTIONS”, paragraph 8 shall be omitted.
