## ORDINANCE

to amend the Sind Local Government Ordinance, 1979.

WHEREAS the Federal Shariat Court has directed to make certain Preamble. amendments in the Sind Local Government Ordinance, 1979;

AND WHEREAS it is expedient to amend the Sind Local Government Ordinance, 1979, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

Short title and commencement.

- 1. (1) This Ordinance may be called the Sind Local Government (Second Amendment) Ordinance, 1984.
  - (2) It shall come into force at-once.

Amendment of Schedule II to Sind Ordinance XII of 1979.

- 2. In the Sind Local Government Ordinance, 1979, hereinafter referred to as the said Ordinance, in Schedule II, under the heading "OPTIONAL FUNCTIONS"—
  - (a) in paragraph 32, in clause (c), the fullstop at the end shall be replaced by a semi-colon and thereafter the following new clause shall be added:—
    - "(d) earmarking of land for mosques where necessary.";
  - (b) in paragraph 36, in sub-paragraph (3), the fullstop shall be replaced by a colon and thereafter the following proviso shall be added:—
    - "Provided that no action shall be taken under this paragraph unless the person likely to be affected thereby is given an opportunity of being heard.";
  - (c) in paragraph 61, after clause (d), the following new clause shall be inserted:—
    - "(dd) provide and promote religious education;";
  - (d) in paragraph 69, in clause (d), the full-stop shall be replaced by a semi-colon and thereafter the following new clause shall be added:—
    - "(e) undertake construction and maintenance of mosques.".

Amendment of shedule III to Sind Ordinance XII of 1979.

- 3. In the said Ordinance, in Schedule III under heading "OPTIONAL FUNCTIONS"—
  - (a) after paragraph 8, the following new paragraph shall be inserted:—
    - "8-A Provision and Promotion of religious education.";
  - (b) after paragraph 70, the following new paragraph shall be added:—
    - "71. Construction and maintenance of mosques.".
