## AN

## **ORDINANCE**

to amend the Sindh Incumbered Estates Act, 1896.

WHEREAS the Federal Shariat Court has directed to make certain Preamble. amendments in the Sindh Incumbered Estates Act, 1896;

AND WHEREAS it is expedient to amend the Sindh Incumbered Estates Act, 1896, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, and the Provisional Constitution Order, 1981, the

Governor of Sind is pleased to make and promulgate the following Ordinance:—

Short title and commencement.

- 1. (1) This Ordinance may be called the Sindh Incumbered Estates (Amendment) Ordinance, 1984.
  - (2) It shall come into force at-once.

Amendment of long title and preamble of Act XX of 1896. 2. In the Sindh Incumbered Estates Act, 1896, hereinafter refersed to as the said Act, in the long title and preamble the words "jagirdars and" shall be omitted.

Amendment of section 2 of Act XX of 1896. 3. In the said Act, in section 2, clauses (1) and (2) shall be omitted.

Amendment of section 3 of Act XX of 1896.

- 4. In the said Act, in section 3—
  - (a) in sub-section (1), the words "jagirdar or" wherever occurring shall be omitted;
  - (b) in sub-section (2), the word and comma "jagirdar," shall be omitted.

Amendment of section 4 and 29 of Act XX of 1896. 5. In the said Act, in section 4 and in section 29, the words "jagirdar or" wherever occurring shall be omitted.

Amendment of section 10 of Act XX of 1896. 6. In the said Act, in section 10, for the words and commas "jagirdar or Zamindar, as the case may be," the word and comma "Zamindar," shall be substituted.

Amendment of section 11 of Act XX of 1896. 7. In the said Act, in section 11, in sub-section (1), in the third para, the words "jagirdar or other" shall be omitted.

Omission of section 25 of Act XX of 1896. 8. In the said Act, section 25 shall be omitted.
