## PROVINCIAL ASSEMBLY OF SIND NOTIFICATION

Karachi, the 26th November, 1986

No. PAS/Legis-B-7/86.—The N.E.D. University of Engineering and Technology (Amendment) Bill, 1986 having been passed by the Provincial Assembly of Sind on 20th October, 1986 and assented to by the Governor of Sind-on 28th October, 1986 is hereby published as an Act of the Legislature of Sind.

THE N.E.D. UNIVERSITY OF ENGINEERING AND TECHNOLOGY (AMENDMENT) ACT, 1986

SIND ACO NO. VIII OF 1986

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra Ordinary) dated 26th November, 1986).

AN

to amend the N.E.D. University of Engineering and Technology Act, 1977.

WHEREAS it is expedient to amend the N.E.D University of Preamble Engineering and Technology Act, 1977, in the manner hereinafter appearing;

It is hereby enacted as follows:---

- 1. (1) This Act may be called the N.E.D. University of Engineering Short title and Technology (Amendment) Act, 1986.
  - (2) It shall come into force at once.
- 2. In the N.E.D. University of Engineering and Technology Act, Amendment 1977, hereinafter referred to as the said Act, in section 2, after clause (m), of section 2 of Sind Act the following shall be inserted:—

  (II of 19 77)

"(mm) "Pro-Vice-Chancellor" means the Pro-Vice-Chancellor of the University;".

Amendment of section 15 of Sind Act III of 1977.

3. In the said Act, in section 15, in sub-section (1), after clause (i), the following shall be inserted:-

"(i-a) the Pro-Vice-Chancellor:".

Amendment of section 17 of Sind Act III of 1977.

In the said Act, in section 17, in sub-section (1), after clause (i), the following shall be inserted: -

"(i-a) the Pro-Vice-Chancellor.".

Amendment of section 26 of Sind Act III of 1977.

5. In the said Act, in section 26, after clause (i), the following shall be inserted:-

"(i-a) the Pro-Vice-Chancellor;".

Insertion of section 28-A in Sind Act in Sind Act III of 1977. 6. In the said Act, after section 28, the following shall be inserted:

28-A. (1) The Chancellor may in consultation with the "Pro-Vice. Vice-Chancellor, appoint a Pro-Vice-Chancellor for the Chancellor main campus or for additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as the Chancellor may determine.

- (2) Where a Pro-Vice-Chancellor is appointed under sub-section (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed as the Chancellor may delegate to him.".
- 7. The N.E.D. University of Engineering and Technology University Repeal of Sind Ordi- (Amendment) Ordinance, 1986 is hereby repealed. of 1986.
