THE N.E.D. UNIVERSITY OF ENGINEERING AND TECHNOLOGY (AMENDMENT) ORDINANCE, 1984.

SIND ORDINANCE NO. LIX OF 1984.

AN

ORDINANCE

to amend the N.E.D. University of Engineering and Technology 'Act, 1977.

WHEREAS the Federal Shariat Court has directed to make certain Preamble. amendments in the N.E.D. University of Engineering and Technology Act, 1977;

AND WHEREAS it is expedient to amend the N.E.D. University of Engineering and Technology Act, 1977, in the manner hereinafter appearing:

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, and the Provisional Constitution Order, 1981, the

Governor of Sind is pleased to make and promulgate the following Ordinance:—

Short title and commencement.

- 1. (1) This Ordinance may be called the N.E.D. University of Engineering and Technology (Amendment) Ordinance, 1984.
 - (2) It shall come into force at-once.

Amendment of section 36 of Sind Act III of 1977.

2. In the N.E.D. University of Engineering and Technology Act, 1977, hereinafter referred to as the said Act, in section 36, the full-stop appearing at the end shall be replaced by a colon and thereafter the following proviso shall be added:—

"Provided that no order in appeal or review shall be made unless the appellant or the applicant, as the case may be, has been given an opportunity of being heard.".

Amendment of section 45 of Sind Act III of 1977.

3. In the said Act, in section 45, the full-stop at the end shall be replaced by a colon and thereafter the following proviso shall be added:—

"Provided that no order in appeal shall be passed unless the appellant has been given an opportunity of being heard.".

Amendment of section 50 of Sind Act III of 1977. 4. In the said Act, in section 50, between the word "done" and the word "under" the words "in good faith" shall be inserted.
