SIND ORDINANCE No. LXVI OF 1984.

AN

ORDINANCE

to amend the Sind Orphanages (Supervision and Control) Act, 1976.

WHEREAS the Federal Shariat Court has directed to make certain Preamble. amendments in the Sind Orphanages (Supervision and Control) Act, 1976;

AND WHEREAS it is expedient to amend the Sind Orphanages (Supervision and Control) Act, 1976, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

- 1. (1) This Ordinance may be called the Sind Orphanages (Supervision and Control) (Amendment) Ordinance, 1984.
 - (2) It shall come into force at-once,

mendment Sind Act II of 2. In the Sind Orphanages (Supervision and Control) Act, 1976, hereinafter referred to as the said Act, throughout the Act except sections 27 and 28, for the word "orphanage" and the word "Orphanages" and the words "an orphanage" wherever occurring, the word "Darul-Atfal" and the words "a Darul-Atfal" shall respectively be substituted.

mendment f section 2 f Sind Act II 1976.

- 3. In the said Act, in section 2-
 - (i) after clause (d), the following new clause shall be inserted:—

 "(dd) "Darul-Atfal" means a place or an institution used for receiving, maintaining and looking after orphans.";
 - (ii) clause (k) shall be omitted.

Amendment of section 4 of Sind Act VII of 1976. 4. In the said Act, in section 4, in the proviso to sub-section (3), the full-stop at the end shall be replaced by a colon and thereafter the following new proviso shall be added:—

"Provided further that no member shall be removed unless he is given an opportunity of being heard.".

Amendment of section 17 of Sind Act VII of 1976. 5. In the said Act, in section 17, the full-stop at the end shall be replaced by a colon and thereafter the following proviso shall be added:—

"Provided that no order shall be passed unless the appellant is given an opportunity of being heard.".
