No. PAS/Legis-B-2/85.—The Sind Finance Bill having been passed by the Provincial Assembly of Sind on 13th June, 1985 and assented to by the Governor of Sind on 17th June, 1985 is hereby published as an Act, of the Legislature of Sind:—

THE SIND FINANCE ACT, 1985

SIND ACT NO. I OF 1985

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary) dated 23rd June, 1985).

AN

ACT

to rationalize and abolish certain taxes in the Province of Sind.

WHEREAS, it is expedient to rationalize and abolish certain taxes in the Province of Sind; Preamble.

It is hereby enacted as follows:—

1. (1) This Act, may be called the Sind Finance Act, 1985.
- (2) It shall come into force on and from the first day of July, 1985.
