#### **ORDINANCE**

to amend the Sind Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sind Local Government Preamblo. Ordinance, 1979, in the manner hereinafter appearing:

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:

1. (1) This Ordinance may be called the Sind Local Government Short title (Fourth Amendment) Ordinance, 1983.

THEREAS it is expedient to amend the Sind Local Government Preamble.

NOW, THEREFORE, in pursuance of the Proclamation of the fifth of July, 1977 and the Provisional Constitution Order, 1981, the ernor of Sind is pleased to make and promulgate the following.

1. (1) This Ordinance may be called the Sind Local Government Shortitle and commencement.

in the said Ordinance, in Schedule V. in Part III, for clause (6), the clause shall be substituted:—

Toll on the export of goods to be called Rawangi Mahsool by District Councils only, and may be shared by the District Council with such Councils of the District and in such ratio as and when directed by Government.".
