WHEREAS it is expedient to amend the Sind Cotton Control Ordinance, Preamble. 1966 and the Sind Finance Act, 1975, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sind Laws (Amendment) Act, 1985, Short title
 - (2) It shall come into force at once.

Amendment of section 30 of West Pakistan Ordinance XX of 1966.

- 2. In the Sind Cotton Control Ordinance, 1966, in Section 30, in subsection (2), for clause (1), the following shall be substituted:—
 - "(1) the fees to be paid by the occupiers of factories or by cotton dealers or by managers of companies at the rate to be prescribed by Government:-
 - (i) for the development and improvement of agriculture relating to cotton crop;
 - (ii) for the development schemes of the local area undertaken by the councils constituted under the Sind Local Government Ordinance, 1979, to the extent of twenty five percent of the fee so collected; and
 - (iii) for meeting the expenses on the administration of this Ordinance;".
 - 3. In the Sind Finance Act, 1975, in section 8—
 - (a) in sub-section (1)—
 - (i) the word 'development' shall be omitted;
 - (ii) between the word 'rice' and the word 'and', the words and commas "and for development schemes of the local area undertaken by the councils constituted under the Sind Local Government Ordinance, 1979" shall be inserted:
 - (b) after sub-section (3), the following sub-section shall be inserted: -
 - "(4) The funds allocated for the development schemes undertaken by the councils shall not exceed twenty five percent of the total collection of the fees in the preceding year,".
