No. PAS/Legis-B-10/85.—The Sind Assembly Members (Salaries and Allowances) (Amendment) Bill, 1985 having been passed by the Provincial Assembly of Sind on 18th December, 1985 and assented to by the Governor of Sind on 31st December, 1985 is hereby published as an Act of the Legislature of Sind.

*to amend the Sind Assembly Members (Salaries and Allowances)
Act, 1974*

WHEREAS it is expedient to amend the Sind Assembly Members (Salaries and Allowances) Act, 1974, in the manner hereinafter appearing; Preamble.

It is hereby enacted as follows:—

Short title

1. (1) This Act may be called the Sind Assembly Members (Salaries and Allowances) (Amendment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have taken effect on and from the date of the first meeting of the Assembly after the tenth day of March, 1985.

2. In the Sind Assembly Members (Salaries and Allowances) Act, 1974, hereinafter referred to as the said Act, in section 3, for the words "one thousand rupees", the words "two thousand rupees" shall be substituted.

3. In the said Act, in section 4, for the words "seventy five rupees", the words "one hundred and fifty rupees" shall be substituted.

5. In the said Act, in section 5, in clause (c), for the words "fifty paisa per mile", the words "one rupee and twenty paisa per kilometer" shall be substituted.

6. In the said Act, in section 6, in clause (b), for the words "rupees one hundred and fifty", the words "five hundred rupees" shall be substituted.
