SIND ORDINANCE NO. XIII of 1981

ORDINANCE

to amend the Sind Civil Courts Ordinance, 1962 and the Sind Civil Courts (Amendment) Ordinance, 1981.

WHEREAS it is expedient to amend the Sind Civil Courts Ordin-Preamble. ance, 1962 and the Sind Civil Courts (Amendment) Ordinance, 1981, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sind Civil Courts (Second Short title and commen- Amendment) Ordinance, 1981. cement.

(2) It shall come into force at once.

Amendment of section 7 of West Pakistan Ordinance II of 1962,

2. In the Sind Civil Courts Ordinance, 1962, hereinafter referred to as the said Ordinance, in section 7, the full-stop at the end shall be replaced by a colon and thereafter the following proviso shall be added:

"Provided that the Civil Suits and proceedings of the value not exceeding one lac of rupees in respect of Karachi Districts pending in the High Court immediately before the commencement of the Sind Civil Courts (Amendment) Ordinance, 1981 shall be disposed of by the High Court except the Suits and proceedings which, on coming into force of the afore-mentioned Amendment Ordinance, stood transferred to the District Court and have already been decided by the said Court.".

3. In the said Ordinance, in section 18, in sub-section (1), in clause (a), Amendment of section 18 for the words "twenty-five thousand rupees", the words "fifty thousand West rupees" shall be substituted. Pakistan Ordinance II
