Karachi, the 15th April, 1976

No. PAS/Legis/Bill-6/76.—The Sind Universities (Amendment) Bill, 1976 having been passed by the Provincial Assembly of Sind on the 17th March, 1976 and assented by the Governor of Sind on 10th April, 1976, is hereby published as an Act of the Legislature of Sind:—

THE SIND UNIVERSITIES (AMENDMENT) ACT, 1976.

SIND ACT NO. VIII OF 1976.

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary), dated 15th April, 1976).

An Act

to further amend the University of Sind Act, 1972 and the University of Karachi Act, 1972.

WHEREAS it is expedient to amend the University of Sind Act, 1972 Preamble, and the University of Karachi Act, 1972, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sind Universities (Amendment) Short title comand commencement.

(2) It shall come into force at once.

Amendment of Sind Acts XXIV and XXV of 1972

- 2. In the University of Sind Act, 1972 and the University of Karachi Act, 1972 including the First Statutes thereto—
 - (i) for the word "Treasurer", wherever occurring, the words "Director of Finance" shall be substituted;
 - (ii) in section 2, after clause (n), the following new clause shall be inserted:—
 - "(nn) 'Pro-Vice-Chancellor' means a Pro-Vice-Chancellor of the University;";
 - (iii) in section 3-
 - (a) in sub-section (1), before the full-stop the words "but Government shall have power to set up any Additional Campus, at any place within the jurisdiction of the University or, by converting any educational institution or college under control and management of the University under section 36-A" shall be added:
 - (b) in sub-section (2)-
 - (i) for clause (i), the following shall be substituted:—
 "(i) the Chancellor and Pro-Chancellor; and—-
 - (a) at the main campus, the Vice-Chancellor, Pro-Vice-Chancellor, Deans, Principals, Directors, Chairmen of Teaching Departments, Registrar, Director of Finance, Controller of Examinations, Librarian, Chief Accountant, Bursar, Auditor and such other Officers as may be prescribed;
 - (b) at the Additional Campus, the Pro-Vice-Chancellor, Deans, Chairmen of Teaching Departments and such other Officers as may from time to time be appointed by the Chancellor.":
 - (ii) in clause (iv), the full-stop shall be replaced by a colon and thereafter the following proviso shall be added:—

"Provided that the Chancellor may, in case of Additional Campus set up in any educational institution or college under the control and management of the University, establish a Board of Governors under section 36-A, in lieu of the Officers and employees mentioned in sub-clause (b) of clause (i).";

- (iv) in section 9-
 - (a) after clause (iii), the following clause shall be inserted:—
 "(iii-a) the Pro-Vice-Chancellor;";
 - (b) after clause (x), the following new clauses shall be inserted:—

(x-b) the Bursar;

(x-c) the Auditor;";

- (v) in section 10, after sub-section (6), the following shall be added-
 - "(7) The Chancellor may, subject to the provisions of this Act, and general or special orders of Government, delegate all or any of the powers and functions of any authority, officer or employee of the University at its main campus, to any authority, officer, employee or any other person at its Additional Campus for the purpose of exercising such powers and performing such functions in relation to such Additional Campus, and for this purpose the Chancellor may create new posts or positions at the Additional Campus.";
- (vi) after section 14, the following new section shall be inserted: -
- Pro-Vice-Chancellor shall be appointed for a period of four years by the Chancellor in consultation with the Vice-Chancellor on such terms and conditions as Chancellor may determine, and shall hold office during the pleasure of the Chancellor.
 - (2) The Pro-Vice-Chancellor shall, subject to over-all control and supervision of the Vice-Chancellor supervise the work of Director Finance, Registrar, the Controller of Examinations and other administrative work of the University; provided that the Pro-Vice-Chancellor of Additional Campus shall in relation to that Campus exercise such powers and perform such functions of any authority. Officer or employee of the University as may be delegated to him by the Chancellor.";
- tvii) section 16 shall be numbered as sub-section (1) of that section and thereafter the following new sub-section shall be added:—
 - "(2) The Director of Finance shall be assisted by the Chief Accountant, Bursar and Auditor.";
- (viii) for section 18, the following shall be substituted:-
 - "18. The Chief Accountant, Bursar and Auditor shall be

Chief Accountant, Bursar and Auditor,

whole time Officers of the University.";

(lx) in section 20, in sub-section (1), after clause (iii), the following clause shall be inserted:—

"(iii-a) the Pro-Vice-Chancellors;";

- (x) in section 22, in sub-section (1), after clause (i), the following clause shall be inserted:—
 - "(i-a) the Pro-Vice-Chancellor;";
 - (xi) after the second proviso to sub-section (2) of section 28, the following shall be added as the third proviso:—

"Provided also that statutes concerning any of the matters mentioned in clause (k) of sub-section (1), shall be made by the Chancellor.":

(xii) after section 36, the following section shall be added:-

Taking over of institution or college.

- "36-A. (1) The Chancellor may, on request of any affiliated institution or college, direct that the control and management of such educational institution or college may be taken over by the University.
- (2) The Chancellor may, for the efficient management and control of such educational institution or college establish a Board of Governors.
 - (3) The Board of Governors shall consist of-
 - (i) the Pro-Chencellor Chairman;
 - (ii) the Vice-Chancellor ... Vice-Chairman;
 - (iii) a Pro-Vice-Chancellor Member/ Secretary;
 - (iv) such other Members as may be appointed by the Chancellor.
- (4) Subject to special or general direction of the Chancellor the Board of Governors shall excreise general supervision and control over the affairs of such institution or college and without prejudice to the generality of these powers it shall—
 - (a) formulate the policy for running the institution or college in the light of guide lines issued by the University from time to time;
 - (b) control and administer the property of the institution or college;
 - (c) manage and regulate the funds, finances, assets and investments of the institution or college;
 - (d) maintain the accounts of the institution or college in the prescribed form and get such accounts audited in the prescribed manner; and
 - (e) appoint teachers and other employees of the institution or college and have the power to take disciplinary action against them.";

(xiii) after section 40, the following shall be inserted as section 40-A:—

"40-A. An officer, teacher or other employee of the

Age of superannuation. University shall retire from service-

 (i) on such date, after he has completed twenty-five years of service qualifying for pension or other retirement benefits, as the competent authority may direct; or

- (ii) where no direction is given under clause (i), on completion of sixty years age, in case of a teacher and nfty-eight years of age in any other case.
- Explanation.—In this section "competent authority" means the appointing authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the other, teacher or other employee concerned.";
 - (xiv) after section 50, the following shall be added:-
- "51. No Court shall have jurisdiction to entertain any proceedings, grant any injunction or make any order in Bar of Jurisdiction. relation to any thing done or purported to have been done or intended to be done under this Act.
- No. suit or legal proceedings shall lie against Government, the University or any authority, Officer or employee of Government or University or any person in respect of any Indemnity. thing which is done or purported to have been done or intended to be, or has been, done under this Act.";
 - (xv) in the First Statutes, in Paragraph 8, in clause (1)-
 - (i) for sub-clause (i), the following shall be substituted:-
 - "(a) in the case of main campus-
 - (i) the Pro-Vice-Chancellor (Chairman);";
 - (ii) in sub-clause (v), the word "and" appearing at the end shall be omitted;
 - (iii) in sub-clause (vi), the full stop appearing at the end shall be replaced by a semi-colon and the word ";and" and thereafter the following shall be added:-
 - "(vii) one nominee of the University Grants Commission.";
 - (b) in the case of Additional Campus-
 - (i) the Pro-Vice-Chancellor (Chairman);
 - (ii) two Chairmen of the Teaching Departments to be nominated by the Pro-Vice-Chancellor or where there is a Board of Governors, by such Board;

- (iii) one nominee of the Chancellor;
- (iv) one nominee of the University Grants Commission;
 - (v) Director, Finance.".

Repeal of 3. The Sind Universities (Amendment) Ordinance, 1976, is hereby Sind Ordinance IV of repealed.
