### NOTIFICATION

Karachi, the 3rd April, 1974

No. PAS/Legis/Bill-6/74.—The West Pakistan Animals Slaughter Control (Sind Amendment) Bill, 1974 having been passed by the Provincial Assembly of Sind on the 19th March, 1974 and assented to by the Governor of Sind on the 3rd April, 1974 is hereby published as an Act of the Legislature of Sind:—

THE WEST PAKISTAN ANIMALS SLAUGHTER CONTROL (SIND AMENDMENT) ACT, 1974

SIND ACT NO. VII OF 1974

AN

ACT

to amend the West Pakistan Animals Slaughter Control Act, 1963, in its application to the Province of Sind.

WHEREAS it is expedient to amend the West Pakistan Animals Preamble Slaughter Control Act, 1963, in its application to the Province of Sind, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the West Pakistan Animals Slaughter Short title and comment (Sind Amendment) Act, 1974.
  - (2) It shall come into force at once

2. In the West Pakistan Animals Slaughter Control Act, 1963 in its Amendment of section 2 application to the Province of Sind (hereinafter referred to as the said Act), in section 2, for clause (k), the following shall be substituted:-Pakistan Act III 1963. "(k) 'useful animal' means-

(i) any animal below the age of one year;

- (ii) a female sheep or goat of the age exceeding one year but not exceeding four years, which is pregnant or fit for breeding purposes;
- (iii) a female animal, other than sheep or goat, of the age exceeding one year but not exceeding three years;
- (iv) a female animal, other than sheep or goat, which is pregnant or in milk or fit for breeding purposes;
- (v) a male animal, other than sheep or goat, of the age exceeding three years but not exceeding ten years, which is fit for draught purposes;

but does not include any such animal which, on account of culling, injury, illness or other cause, is certified in writing by a Veterinary Officer or any Gazetted Officer of the Animal Husbandry Department as not likely to live or as no longer a useful animal for the purposes of this Act;".

3. In the said Act, after section 8, the following section 8-A shall be Insertion of inserted: section 8-A West Pakistan Act III of 1963.

"8-A. (1) An offence under this Act shall be tried by Cognizance and trial the Magistrate of the First Class. of offences.

> (2) No Court shall take cognizance of an offence under this Act except on a report in writing made by a Veterinary Officer or any other officer specially authorised by Government in this behalf.".

The West Pakistan Animals Slaughter Control (Sind Amendment) Repeal of Sind Ordinance, 1974, is hereby repealed.
