## ODRINANCE

to amend the Sind Small Industries and Handicrafts Development Corporation Act, 1972.

WHEREAS, it is expedient to amend the Sind Small Industries and Preamble. Handicrafts Development Corporation Act, 1972, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

1. (1) This Ordinance may be called the Sind Small Industries and Short title Handicrafts Development Corporation (Amendment) Ordinance, 1978.

Amendment of section 5 of Sind Act XXVI of 1972.

- 2. In the Sind Small Industries and Handicrafts Development Corporation Act, 1972, hereinafter referred to as the said Act, in section 5-
  - (i) for sub-section (1), the following shall be substituted: -
    - "(1) The Board shalt consist of the following: -
      - (a) Secretary in charge of Industries and Chairman Mineral Development Department, Government of Sind:
      - (b) Secretary, Finance Department, Government of Sind;

(c) The Managing Director of the Corpora-Member tion:

(d) one representative of the Planning and Development Department, Government of Sind, not below the rank of Deputy Secretary to be nominated by the Additional Chief Secretary (Development);

(e) one representative of the All Pakistan Women's Association, dealing with the industrial sector;

(f) one representative each from the Industrial Development Bank of Pakistan, the Export Promotion Bureau, Government of Pakistan and the Trading Corporation of Pakistan.

(g) two members of Federation of the Chambers of Commerce representing the Province of Sind.

(ii) in sub-section (3), for the words and comma "Director, Small Industries and Development Corporation", the words "Managing Director of the Corporation" shall be subsitute.

Amendment [ of section 7 of Sind Act XXVI of 1972.

3. In the said Act, in section 7, the commas and the words "other than a Member who is a Member of the Provincial Assembly," shall be omitted.

Validation of actions aken.

4. The powers and functions of the Board under the Sind Small Industries and Handicrafts Development Corporation Act, 1972 which have been exercised and performed by the Secretary in charge of the Industries and Mineral Development Department before coming into force of this Ordinance shall, notwithstanding anything contained in the said Act, be deemed to have been exercised or, as the case may be, performed by the Board.
