No. PAS/Legis-B-2/73.—The West Pakistan Employees' Social Security (Sind Amendment) Bill, 1973 having been passed by the Provincial Assembly of Sind on the 5th June, 1973 and assented to by the President of Pakistan on the 4th July, 1973 is hereby published as an Act, of the Legislature of Sind:—

ACT

to amend the West Pakistan Employees' Social Security Ordinance, 1965, in its application to the Province of Sind.

WHEREAS, it is expedient to amend the West Pakistan Employees' Preamble. Social Security Ordinance, 1965, in its application to the Province of Sind, in the manner hereinafter appearing;

Short title and commencement.

- (1) This Act may be called the West Pakistan Employees' Social Security (Sind Amendment) Act, 1973.
 - (2) It shall come into force at once.

Amendment of section 5 of West Pakistan Ordinance X of 1965.

- 2. In the West Pakistan Employees' Social Security Ordinance, 1965, in its application to the Province of Sind, in section 5, in sub-section (1)—
 - (i) for clause (a), the following shall be substituted, namely:—
 - "(a) a person who is a Minister of the Province or who is or has been a Judge of the High Court or a senior officer in the service of Pakistan not below the rank of a Commissioner of a Division or Joint Secretary to the Central Government or Secretary to Government, and such person shall be the Chairman of the Governing Body;"; and
 - (ii) for clause (e), the following clauses shall be substituted, namely:-
 - "(e) the Commissioner:
 - (f) the Medical Adviser, ex-officio; and
 - (iii) in sub-section (1) of Section 12, clause (d) shall be omitted
- 3. The West Pakistan Employees' Social Security (Sind Amendment) Ropeal Sind Ordi-nance V of Ordinance, 1973, is hereby repealed. 1973.
