NOTIFICATION

Karachi, the 5th December, 1973.

No. PAS/Legis/B-20/73.—The Sindh Boards of Intermediate and Secondary Education (Amendment) Bill, 1973 having been passed by the Provincial Assembly of Sindh on the 24th November, 1973 and assented to by the Governor of Sindh on the 5th December, 1973 is hereby published as an Act of the Legislature of Sindh:—

THE SIND BOARDS OF INTERMEDIATE AND SECONDARY EDUCATION (AMENDMENT) ACT, 1973.

Sindh Act No. 20 of 1973.

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 5th December, 1973).

AN

ACT

to further amend the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972.

WHEREAS it is expedient to further amend the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972, in the manner hereinafter appearing;

Preamble.

It is hereby enacted as follows:—

Short title
and com-
mencement.

1. (1) This Act may be called the Sind Boards of Intermediate and Secondary Education (Amendment) Act, 1973.

(2) It shall come into force at once.

2. In the Sind Boards of Intermediate and Secondary Education Ordinance, 1972, hereinafter referred to as the said Ordinance, in section 2—

(i) for clause (b), the following shall be substituted:—

“(b) ‘Board’ means a Board constituted and established under section 3;”;

(ii) for clause (e), the following shall be substituted:—

“(e) ‘Committee’ means a Committee constituted under this Ordinance and, except for the purposes of sections 15 and 17, includes the Joint Academic Co-ordination Committee;” and

(iii) in clause (u), for the words “Boards at Hyderabad and Khairpur”, the words “the Board at Hyderabad” shall be substituted.

3. In the said Ordinance, for sub-section (1) of section 3, the following shall be substituted:—

“(1) There shall be constituted and established on and from the date to be notified by Government—

(a) in Karachi—

(i) a Board called the Board of Secondary Education, Karachi; and

(ii) a Board called the Board of Intermediate Education, Karachi; and

(b) at Hyderabad a Board called the Board of Intermediate and Secondary Education, Hyderabad.”.

of Sind

4. In the said Ordinance, in sub-section (1) of section 4, for clauses (iii), (vi), (vii) and (viii), the following clauses shall respectively be substituted:—

“(iii) in the case of—

(a) the Board of Secondary Education, Karachi, the Director of School Education;

- (b) the Board of Intermediate Education, Karachi, the Director of College Education; and
- (c) the Board of Intermediate and Secondary Education, Hyderabad, the Directors of School Education and College Education;
- (vi) one Headmaster or Headmistress in the case of the Board of Secondary Education, Karachi, and one Principal in other cases, to be nominated by the Controlling Authority;
- (vii) one representative of Heads of Schools elected by and from among such Heads in the case other than that of the Board of Intermediate Education, Karachi;
- (viii) one representative of Heads of Intermediate Colleges, elected by and from among such Heads in a case other than that of the Board of Secondary Education, Karachi;”.

5. In the said Ordinance, in sub-section (1) of section 9, for the words “the institutions within the territorial limits that”, the words “such institutions within such territorial limits as” shall be substituted.

6. In the said Ordinance, in section 11—

Amendment of section 11 of Sind Ordinance VI of 1972.

- (a) in sub-section (1), for the words “and Secondary Education”, the words and comma “or Secondary Education or both, as the case may be” shall be substituted;
- (b) in sub-section (2), between the words “a Board” and the word “shall” the words “having jurisdiction” shall be inserted.

7. In the said Ordinance, for sub-section (3) of section 15, the following shall be substituted:—

Amendment of section 15 of Sind Ordinance VI of 1972.

“(3) The Chairman shall be the principal executive and academic officer of the Board and shall, when present, preside at the meeting of the Board or a Committee.”.

8. In the said Ordinance, after section 15, the following new section shall be inserted:—

Insertion of section 15-A in Sind Ordinance VI of 1972.

“15-A. (1) The Joint Academic Co-ordination Committee shall consist of the following members:—

Joint Academic Co-ordination Committee.

- (a) the Secretary to Government of Sind, Education Department;
- (b) the Chairmen of all Boards;
- (c) the Directors School Education;

- (d) the Directors College Education;
- (e) the Director Technical Education, Sind;
- (f) the Director Curriculum Development, Sind; and
- (g) the Chairman, Sind Text Book Board.

(2) The Secretary to Government of Sind, Education Department shall be the Chairman of the Committee.

(3) The meetings of the Committee shall be held at least once in a year, but the Chairman may, whenever he considers necessary and shall, on requisition of one-third members of the Committee, call a meeting of the Committee.

(4) The quorum for the meeting of the Committee shall be one-third of the total number of members, a fraction being counted as one.

(5) The Committee shall have the general superintendence and control of, and be responsible for, the maintenance of the standards of teaching and examination.

(6) Without prejudice to the generality of the foregoing provisions the Committee shall co-ordinate the functions of the academic committees of the Boards.

9. In the said Ordinance, in section 30, the existing sub-sections (1) and (2) shall respectively be re-numbered as sub-sections (2) and (3) thereof and the following shall be inserted as sub-section (1):—

“(1) On the constitution and establishment of a Board under section 3, the following enactments shall, in relation to such Board, stand repealed:—

- (i) The Board of Intermediate and Secondary Education Hyderabad Ordinance, 1961 (West Pakistan Ordinance XVII of 1961); and
- (ii) The Board of Intermediate and Secondary Education Karachi Ordinance, 1962 (West Pakistan Ordinance III of 1962).”

10. In the said Ordinance, in the Schedule—

- (a) In clauses (i) and (iii) of regulation 1, for the ward “three” the word “four” shall be substituted;
- (b) in regulation 2, paragraph (11) shall be deleted;

(c) in regulation 5—

(i) for clauses (ii) and (iii) of paragraph (1), the following shall be substituted:—

“(ii) In the case of—

(a) the Board of Secondary Education, Karachi, the Chairman, Board of Intermediate Education, Karachi;

(b) the Board of Intermediate Education, Karachi, the Chairman, Board of Secondary Education Karachi; and

(c) the Board of Intermediate and Secondary Education, Hyderabad, the Vice-Chancellor or his nominee;

(iii) in the case of—

(a) the Board of Secondary Education Karachi, the Director of School Education;

(b) the Board of Intermediate Education Karachi, the Director College Education; and

(c) the Board of Intermediate and Secondary Education, Hyderabad, the Directors of School Education and College Education;”;

(ii) in paragraph (2), for the word “three” the word “four” should be substituted;

(d) in regulation 6, for clause (ii) of paragraph (1), the following shall be substituted:—

“(ii) in the case of—

(a) the Board of Secondary Education Karachi, the Director of School Education;

(b) the Board of Intermediate Education, Karachi, the Director College Education; and

(c) the Board of Intermediate and the Secondary Education Hyderabad, the Directors of School Education and College Education;”;

(e) in regulation 7, in paragraph (1), for clauses (a) and (iii) the following shall be substituted:—

“(ii) in the case of—

- (a) the Board of Secondary Education Karachi, the Chairman, Board of Intermediate Education, Karachi;
- (b) the Board of Intermediate Education, Karachi, the Chairman, Board of Secondary Education Karachi; and
- (c) the Board of Intermediate and Secondary Education, Hyderabad, the Vice-Chancellor or his nominee, and

“(iii) in the case of—

- (a) the Board of Secondary Education Karachi, the Director of School Education;
- (b) the Board of Intermediate Education, Karachi, the Director College Education; and
- (c) the Board of Intermediate and Secondary Education Hyderabad, the Directors of School Education and College Education.”.
