DEPAR No. PAS/Legis-B-22/72.—The West Pakistan Primary Education and Local Councils High Schools (Sind Amendment) Bill, 1972 having been passed by the Provincial Assembly of Sind on the 22nd December, 1972 and assented to by the Governor of Sind on the 28th December, 1972 is hereby published as an Act of the Legislature of Sind:—

THE WEST PAKISTAN PRIMARY EDUCATION AND LOCAL COUNCILS HIGH SCHOOLS (SIND AMENDMENT) ACT, 1972.

ACT

to amend the West Pakistan Primary Education Ordinance, 1962 and the West Pakistan Local Councils High School (Taking Over) Ordinance, 1970 in their application to the Province of Sind.

Preamble.

WHEREAS it is expedient to amend the West Pakistan Primary Education Ordinance, 1962 and the West Pakistan Local Councils High Schools (Taking Over) Ordinance, 1970;

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the West Pakistan Primary Education and Local Councils High Schools (Sind Amendment). Act, 1972.
- (2) It shall be deemed to have taken effect on and from the first day of October, 1972.
