WHEREAS it is expedient to amend the West Pakistan Prevention of Gambling Ordinance, 1961, in its application to the Province of Sind, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short titl and Come. 1. (1) This Act may be called the West Pakistan Prevention of mencement Gambling (Sind Amendment) Act, 1972.

- Amendment 3. In section 3 of the Principal Ordinance, the full stop at the end of section 3 of clause (e) shall be replaced by a semi-colon and the word "and", and of West Pakistan Ordinance I
 - "(f) 'Tourist Complex' means a private building or part thereof used for musical or theatrical performances, entertainments and playing of various games for foreigners;".

- 4. After section 11 of the Principal Ordinance, the following new Addition of Sections shall be added, namely:—

 11-A and 11-B to West Pakistan Ordinance I of 1961.
 - "11-A. Government may issue a licence for establishing, maintaining, and running of a Tourist Complex on such conditions as may be prescribed.
 - 11-B. Government may make rules for carrying into effect, the provisions Power to make rules. of this Ordinance, and in particular for—
 - (a) prescribing conditions for grant of licence for Tourist Complex;
 - (b) regulating admission to the Tourist Complex;
 - (c) operation of various games to be played in the Tourist Complex."
- 5 The West Pakistan Prevention of Gambling (Sind Amendment) Ordinance, 1972, is hereby repealed.
