#### NOTIFICATION

Karachi, the 25th June, 1975

No. PAS/Legis/Bill-12/75.—The Sind Borstal Schools and the Sind Children (Amendment) Bill, 1975 having been passed by the Provincial Assembly of Sind on the 11th June, 1975 and assented to by the Governor of Sind on 25th June, 1975 is hereby published as an Act of the Legislature of Sind:—

#### THE SIND BORSTAL SCHOOLS AND THE SIND CHILDREN (AMENDMENT) ACT, 1975.

SIND ACT No. XIV OF 1975.

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-ordinary), dated 25th June, 1975.

ACT

*to amend the Sind Borstal Schools Act, 1955 and the Sind Children Act, 1955.*

WHEREAS it is expedient to amend the Sind Borstal Schools Act, 1955 and the Sind Children Act, 1955, in the manner hereinafter appearing; Preamble.

It is hereby enacted as follows:—

Short title  
and com-  
mencement.

1. (1) This Act may be called the Sind Borstal Schools and the Sind Children (Amendment) Act, 1975.

(2) It shall come into force at once.

*Part-I Amendments of the Sind Borstal Schools Act, 1955.*

Amendment  
of long title,  
preamble and  
sections 12  
and 15 of  
Sind Act X  
of 1955.

2. In the Sind Borstal Schools Act, 1955, hereinafter in this part referred to as the said Act, in the long title, preamble and sections 12 and 15, for the word "Sind", the words "the Province of Sind" shall be substituted.

Amendment  
of section 2  
of Sind Act  
X of 1955.

3. In the said Act, for sub-section (1) of Section 2, the following shall be substituted, namely:—

"(1) It extends to the whole Province of Sind."

Amendment  
of section 6  
of Sind Act  
X of 1955.

4. In the said Act, in Section 6—

(i) in clause (a), for the words, comma and figures "the Sind Children Act, 1924", the words, comma and figures "the Sind Children Act, 1955" shall be substituted; and

(ii) in clause (b), the words "or an Acceding State in Pakistan" shall be omitted.

Amendment  
of section 8  
of Sind Act  
X of 1955.

5. In the said Act, in Section 8, for the words "Chief Court", the words "High Court" shall be substituted.

Amendment  
of section 13  
of Sind Act  
X of 1955.

6. In the said Act, in Sub-section (2) of Section 13, the words "or an Acceding State in Pakistan" shall be omitted.

Amendment  
of section 14  
of Sind Act  
X of 1955.

7. In the said Act, in Section 14 the words "or an Acceding State in Pakistan" and the words "or State" shall be omitted.

8. In the said Act, for Section 26, the following shall be substituted, namely:—

Substitution of section 26 of Sind Act X of 1955.

“26. The Bombay Borstal Schools Act, 1929, as applicable to Karachi and the Sind Borstal Schools Act, 1929, are hereby repealed”.

Repeal of Bombay Act XVII of 1929 and Sind Act XVII of 1929.

*Part-II Amendments of the Sind Children Act, 1955.*

9. In the Sind Children Act, 1955, hereinafter in this part referred to as the said Act, in the long title, preamble and Sections 3, 73, 84 and 98, for the word “Sind”, the words “the Province of Sind” shall be substituted.

Amendment of long title, preamble and sections 3, 73, 84 and 98 of Sind Act XII of 1955.

10. In the said Act, for Sub-section (2) of Section 1, the following shall be substituted, namely:—

Amendment of section 1 of Sind Act XII of 1955.

“(2) It extends to the whole Province of Sind.”.

11. In the said Act, in Section 3, for the words “of Sind” the word “Province” shall be substituted.

Amendment of section 3 of Sind Act XII of 1955.

12. In the said Act, in clauses (d) and (c) of Sub-section (1) of Section 4, for the words, comma and figures “the Sind Prevention of Prostitution Act, 1951”, the words, comma and figures “the West Pakistan Suppression of Prostitution Ordinance, 1961” shall be substituted.

Amendment of section 4 of Sind Act XII of 1955.

13. In the said Act, in Sections 8, 94 and 96, for the words “Chief Court of Sind”, the words “High Court” shall be substituted.

Amendment of sections 8, 94 and 96 of Sind Act XII of 1955.

14. In the said Act, in Sections 73 and 84, for the word “Sind” the words “the Province” shall be substituted.

Amendment of sections 73 and 84 of Sind Act XII of 1955.

15. In the said Act, in Sub-section (3) of Section 97, for the words, comma and figures “the Sind Borstal Schools Act, 1929”, the words, comma and figures “the Sind Borstal Schools Act, 1955” shall be substituted.

Amendment of section 97 of Sind Act XII of 1955.

16. In the said Act, in Sub-section (2) of Section 98, the words “or State” shall be omitted.

Amendment of section 98 of Sind Act XII of 1955.

Amendment  
of section 110  
of Sind Act  
XII of 1955.

17. In the said Act, in Section 110—

- (i) for the words, commas and figures “Sind Children Act, 1924, is”, the words, commas and figures “Bombay Children Act, 1924, as applicable to Karachi and the Sind Children Act, 1924, are” shall be substituted;
- (ii) for the words “repealed Act”, the words “repealed Acts” shall be substituted; and
- (iii) for the words “that Act”, the words “those Acts” shall be substituted.
