No. PAS/Legis/Bill-17/75.—The Sind Repealing and Amending Bill, 1975 having been passed by the Provincial Assembly of Sind on the 30th July, 1975 and assented to by the Governor of Sind on 16th August, 1975 is hereby published as an Act of the Legislature of Sind:—

THE SIND REPEALING AND AMENDING ACT, 1975.

SIND ACT NO. XVII OF 1975.

(First published after having received the assent of the Governor of Sind the Gazette of Sind (Extra-Ordinary), dated 25th August, 1975.)

AN

ACT

to repeal and amend certain laws in force in the Province of Sind.

WHEREAS it is expedient that certain laws, which are spent or have become un-necessary, or have ceased to be in force otherwise than by express repeal, should be expressly repealed;

Preamble

AND WHEREAS it is further expedient that certain amendments should be made in certain laws;

It is hereby enacted as follows:—

Short title
and commen-
cement. 1. (1) This Act may be called the Sind Repealing and Amending Act, 1975.

(2) It shall come into force at once.

certain laws, 2. The Laws specified in the First Schedule are hereby re-
pealed.

other laws. 3. The laws specified in the third column of the Second Schedule are hereby amended to the extent and in the manner mentioned in the fourth column thereof.
