**NO.PAS/Legis-B-05/2009-** The Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Bill, 2009 having been passed by the Provincial Assembly of Sindh on 15<sup>th</sup> March, 2013 and assented to by the Governor of Sindh on 28<sup>th</sup> March, 2013 is hereby published as an Act of the Legislature of Sindh.

### THE SINDH SPEAKER'S AND DEPUTY SPEAKER'S (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) ACT, 2009.

SINDH ACT NO. XXXIII OF 2013.

#### AN ACT

to amend the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975.

**WHEREAS** it is expedient to amend the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 2009. **Short title and commencement.**
- (2) It shall come into force at once and shall be deemed to have taken effect on and from 1<sup>st</sup> July, 2011.
2. In the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred as the said Act, in Section 3-A, for the words "five thousand", the words "seven thousand" shall be substituted. **Amendment of Section 3-A of the Sind Act No. VII of 1975.**
3. In the said Act, for section 5, the following shall be inserted:- **Amendment of Section 5 of the Sind Act No. VII of 1975.**
- "5 (1) The Salary of the Speaker and Deputy Speaker, shall respectively be eighty thousand and seventy thousand rupees per mensem.
- (2) The Salary mentioned in sub-section (1), shall automatically be increased by Government in proportion increase in salary of civil servants."
4. In the said Act, in section 6, in sub-section (2), for the words "thirty nine thousand and five hundred", and the words "thirty five thousand" the words "fifty five thousand three hundred" and words "forty nine thousand", shall respectively be substituted. **Amendment of Section 6 of the Sind Act No. VII of 1975.**
5. In the said Act, for section 7, the following shall be substituted:- **Amendment of Section 7 of the Sind Act No. VII of 1975.**
- "7. The Speaker or Deputy Speaker, as the case may be, shall be entitled to use two official cars maintained at Government expenses."
6. In the said Act, in section 8, for the words "six thousand", the words "eight thousand four hundred" shall be substituted. **Amendment of Section 8 of the Sind Act No. VII of 1975.**
7. In the said Act, in section 8-A, for the word "both", the words "and a mobile phone on Government expenses" shall be substituted. **Amendment of Section 8-A of the Sind Act No. VII of 1975.**
8. In the said Act, in section 10, for the words "five hundred fifty", the words "seven hundred and seventy" shall be substituted. **Amendment of Section 10 of the Sind Act No. VII of 1975.**
