NO.PAS/Legis-B-05/2009- The Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Bill, 2009 having been passed by the Provincial Assembly of Sindh on 15<sup>th</sup> March, 2013 and assented to by the Governor of Sindh on 28<sup>th</sup> March, 2013 is hereby published as an Act of the Legislature of Sindh.

to amend the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975.

WHEREAS it is expedient to amend the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing;

It is hereby enacted as follows:-

		"5 (1) The Salary of the Speaker and Deputy Speaker, shall respectively be eighty thousand and seventy thousand rupees per mensem.	
		(2) The Salary mentioned in sub-section (1), shall automatically be increased by Government in proportion increase in salary of civil servants."
