to further amend the West Pakistan Cotton Control Ordinance, 1966, in its application to the Province of Sind.

WHEREAS it is expedient to further amend the West Pakistan Cotton Press.

PART IV

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the West Pakistan Cotton Contro (Sind Amendment) Act, 1975.
  - (2) It shall come into force at once.

Substitution of W.P. Ordinance XX of 1966.

- 2. In the West Pakistan Cotton Control Ordinance, 1966, in its appl of section 26 cation to the Province of Sind, hereinafter referred to as the said Ordinance for section 26, the following shall be substituted:
  - "26. (1) Government may, by notification, fix or, regulate the fixa tion of-

Regulation of price of cotton

- (a) price of any variety of cotton or cotton seed in an cotton market or notified area; or
- (b) ginning charges paid to a factory in any area as ma be specified.
- (2) Whoever contravenes the notification issued under sub-section (1 may be punished with imprisonment of either description, which may ex tend to two years or with fine which may extend to twenty-five thousan rupees or with both:

Provided that the amount of fine shall not be less than Rs. 5,000 if only fine is imposed.".

Amendment of section 27 of W.P. Ord nance XX of 1966.

- In the said Ordinance, section 27 shall be numbered as sub-section (1) of that section and after sub-section (1) as so numbered, the following sub-section shall be added:-
  - "(2) Whoever contravenes the notification issued under sul section (1) may be punished with imprisonment of either description which may extend to two years or with fine which may extend t twenty-five thousand rupees or with both.".

Repeal of Sind Ordinance of 1975.

The West Pakistan Cotton Control (Sind Amendment) Ordinance 1975, is hereby repealed.
