No. PAS/Legis-B-8/86.—The Mehran Engineering and Technology University (Amendment) Bill, 1986 having been passed by the Provincial Assembly of Sind on 20th October, 1986 and assented to by the Governor of Sind on 28th October, 1986 is hereby published as an Act of the Legislature of Sind.

THE MEHRAN ENGINEERING AND TECHNOLOGY UNIVERSITY (AMENDMENT) ACT, 1986.

ACT

to amend the Mehran University of Engineering and Technology Act, 1977.

WHEREAS it is expedient to amend the Mehran University of Preamble. Engineering and Technology Act, 1977, in the manner hereinafter appearing;

It is hereby enacted as follows:—

1. (1) This Act may be called the Mehran Engineering and Techne-Short title logy University (Amendment) Act, 1986.

Amendment of section 15 of Sind Act IV of 1977. 3. In the said Act, in section 15, in sub-section (1), after clause (i), the following shall be inserted:—

"(i-a) the Pro-Vice-Chancellor;".

Amendment of section 17 of Sind Act IV of 1977. 4. In the said Act, in section 17, in sub-section (1), after clause (i), the following shall be inserted:—

"(i-a) the Pro-Vice-Chancellor;".

Amendment of section 26 of Sind Act IV of 1977.

5. In the said Act, in section 26, after clause (i), the following shall be inserted:—

"(i-a) the Pro-Vice-Chancellor;".

Insertion of section 28-A in Sind Act IV of 1977... 6. In the said Act, after section 28, the following shall be inserted:—

"Pro-Vice-Chancellor. Vice-Chancellor, appoint a Pro-Vice-Chancellor for the main campus or for additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as the Chancellor may determine.

(2) Where a Pro-Vice-Chancellor is appointed under subsection (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed as the Chancellor may delegate to him."

Repeal of Sind Ordinance III of 1986. 7. The Mehran Engineering and Technology University (Amendment) Ordinance, 1986, is hereby repealed.
