AN ORDINANCE

to amend the Sindh High Density Development Board Act, 2010.

WHEREAS it is expedient to amend the Sindh High Density Development Board Act, 2010, in the manner hereinafter appearing; **Preamble.**

AND WHEREAS the Provincial Assembly is not in session and the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, 1973, the Governor is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sindh High Density Development Board (Amendment) Ordinance, 2013.

Short title and commencement.

(2) It shall come into force at once.

2. In the Sindh High Density Development Board Act, 2010, for section 3, the following shall be substituted:-

Amendment of section 3 of Sindh Act No.X of 2010.

"3. **Constitution of Board.** Government shall constitute a Board for the cities of the Province under this Act. The Board shall consist of the following:-
