THE LARKANA DEVELOPMENT AUTHORITY (REVIVAL AND AMENDING) BILL, 2013.

SINDH BILL NO. 16 OF 2013.

BILL

to revive and amend the law relating to the Larkana Development Authority.

. WHEREAS in order to give impetus and Preamble. encourage the housing industry and provide shelter to the people of the Province, it is expedient to revive and amend the Larkana Development Authority Act, 1994, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Larkana Development Short title and Authority (Revival and Amending), Act, 2013.

- (2) It shall come into force at once.
- The Larkana Development Authority Act, 1993, shall stand revived on and from 1st day of July, 2002,

 Revival of Sindh Act No. XXI of as if it had never been repealed and on revival shall 1994. hereinafter be referred to as the said Act.

In section 2, after clause (e), the following new Amendment of clause shall be inserted:-

section 2 of Sindh Act

"consolidation of land" means No.XXI of "(ee) adjustment of plots in a scheme by way of 1994. exchange or otherwise for the purpose of the scheme;".

In section 4, for sub section (1), the following Amendment of shall be substituted:-

section 4 of Sindh Act

- "(1) Constitution of the Authority.- The No.XXI of Authority shall consist of:-
 - Local Chairman (a) Minister for Government, Public Health Rural Engineering, Development and Housing Town Planning, Sindh

(b) One Local Member of the Member Provincial Assembly to be nominated by Government

Local Member (c) Secretary, Government, Public Health

Engineering, Rural Development and Housing Town Planning Department

(d) Commissioner, Larakana . Member

(e) Chief Engineer, Public Member Health Engineering, Sukkur

(f) Director General Larkana Member/ Development Authority

(g) Two Persons to nominated by Government (one Technocrat and one from Civil Society)

Secretary be Members

In section 9, in sub section (1), after clause (iii), Amendment of the following new clause shall be inserted:-

"(iii-a) consolidate any land in such manner as of 1994. may be prescribed by rules:".

section 8 of Sindh Act No.X

The Larkana Development Authority (Revival and Amending) Act, 2009 (Sindh Act No.VIII of 2009) is Act N.VIII of hereby repealed.

Repeal of Sindh 2009.

All orders made, proceedings taken, appointments, made, acts done by any authority, or by any person, which were made, taken or done, or purported to have been made, taken or done between the first day of July, two thousand two, and the date on which this Act comes into force (both days inclusive), shall, notwithstanding any judgment of any court, be deemed to be and always to have been validly made, taken or done under the Larkana Development Authority Act, 1993 and shall not be called in question in any court or forum on any ground whatsoever.

STATEMENT OF OBJECTS AND REASONS

The law relating to the Larkana Development was repealed during the unelected Government without taking into confidence the political parties and the general public in the year 2002. In order to encourage the housing industry and provide shelter to the general public, it is expedient to revive and amend the Larkana Development Authority Act, 1993 by this enactment,

The Bill seeks to achieve the above object.
