THE SEHWAN DEVELOPMENT AUTHORITY (REVIVAL AND AMENDING) BILL, 2013.

SINDH BILL NO. 18 OF 2013.

A BILL

to revive and amend the law relating to the Sehwan Development Authority.

WHEREAS in order to give impetus and Preamble. encourage the housing industry and provide shelter to the people of the Province, it is expedient to revive and amend the Sehwan Development Authority Act, 1993, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sehwan Development Short title and Authority (Revival and Amending), Act, 2013. commencement.

- (2) It shall come into force at once.
- 2. The Sehwan Development Authority Act, 1993, Revival of Sindh shall stand revived on and from 1st day of July, 2002, as if it had never been repealed and on revival shall 1994. hereinafter be referred to as the said Act.

Throughout the said Act, for the words "District Amendment of Dadu", the words "District Jamshoro" shall be Sindh Act No.V substituted.

In the said Act, in section 2, after clause (b), Amendment of the following new clause shall be inserted:-

section 2 of Sindh Act No.V

- "consolidation of land" means of 1994. adjustment of plots in a scheme by way of exchange or otherwise for the purpose of the scheme;".
- In section 4, for sub section (1), the following Amendment of shall be substituted:-

section 4 of Sindh Act No.V of 1994.

- "(1) Constitution of the Authority.- The Authority shall consist of:-
 - (a) Minister Local Chairman for Government, Public Health Engineering, Development and Housing Town Planning, Sindh
 - (b) One Local Member of the Member Provincial Assembly to be nominated by Government

(c) Secretary, Local Government, Public Health Local Member Engineering, Rural Development and Housing Town Planning Department

(d) Commissioner, Hyderabad Member

(e) Chief Engineer, Public Member Health Engineering, Hyderabad

(f) Director General Sehwan Member/ Development Authority Secretary

(g) Two Persons to be Members nominated by Government (one Technocrat and one from Civil Society)

clause shall be inserted:-

In section 7, after clause (iii), the following new Amendment of

"(iii-a) consolidate any land in such manner as of 1994. may be prescribed by rules;".

section 7 of Sindh Act No.V

All orders made, proceedings taken, Saving. appointments, made, acts done by any authority, or by any person, which were made, taken or done, or purported to have been made, taken or done between the first day of July, two thousand two, and the date on which this Act comes into force (both days inclusive), shall, notwithstanding any judgment of any court, be deemed to be and always to have been validly made, taken or done under the Sehwan Development Authority Act, 1993 and shall not be called in question in any court or forum on any ground whatsoever.

STATEMENT OF OBJECTS AND REASONS

The law relating to the Sehwan Development Authority was repealed during the unelected Government without taking into confidence the political parties and the general public in the year 2002. In order to encourage the housing industry and provide shelter to the general public, it is expedient to revive and amend the Sehwan Development Authority Act, 1993 by this enactment.

The Bill seeks to achieve the above object.
